Industrial Production Index. Base 2000 January 2009

The Industrial Production Index adjusted for calendar effects decreases 20.2% in January, as compared with the same month in 2008

The General Industrial Production Index (IPI) experienced a -23.6% variation in January 2009, in comparison with the same month the previous year.

After adjusting for calendar effects, the interannual rate of the IPI was estimated at -20.2%.

By economic destination of the goods, the variation rates as compared with the same month of 2008 were -16.9% for Consumer goods (-34.1% for Durable consumer goods and -14.0% for Non-durable consumer goods), -33.3% for Capital goods, -31.1% for Intermediate goods and - 3.5% for Energy.

After adjusting for calendar effects, these interannual rates were estimated at -12.6% for Consumer goods (-28.2% for Durable consumer goods and -9.9% for Non-durable consumer goods), -29.9% for Capital goods, -27.6% for Intermediate goods and -2.5% for Energy.

The only activity that experienced an increase in January 2009 was *Mining of coal and lignite*, with a rate of 20.0%.

In contrast, those with the greatest decreases were *Manufacture of motor vehicles, trailers and semi-trailers, with –54.4%, Manufacture of other non-metallic mineral products, with –46.1%, and Other mining and quarrying, with –38.9%.*

Methodological Annex

Change in the Industrial Production Index to base 2005

The National Statistics Institute (INE) is publishing today the first Industrial Production Index (IPI) in base 2005, pursuant to Regulation (EC) no. 1165/98 of the Council on short-term statistics.

This change in the base of comparison to the year 2005 indicates the **updating of the weightings, the basket of representative products and the panel of informant units** of the industrial price indices.

Adaptation of the IPI to CNAE 2009

In addition, beginning this month of January 2009, the Industrial Production Index has adapted to the Classification of Economic Activities in force (CNAE-2009).

The Industrial Production Index with base 2000 used the National Classification of Economic Activities from the year 1993 (CNAE-93). Royal Decree 475/2007, of 13 April 2007, passed National Classification of Economic Activities 2009 (CNAE-2009), to be applied as of January 2009.

In order to **grant continuity to the data series**, the INE has linked all of the series of CNAE-2009 and of the Large Industrial Sectors (LIS) with the indices calculated in this classification from the information that the INE was publishing with base 2000. Some of these linked series begin in the year 1975. In turn, the series from the old National Classification of Economic Activities (CNAE-93) will henceforth no longer be published.
