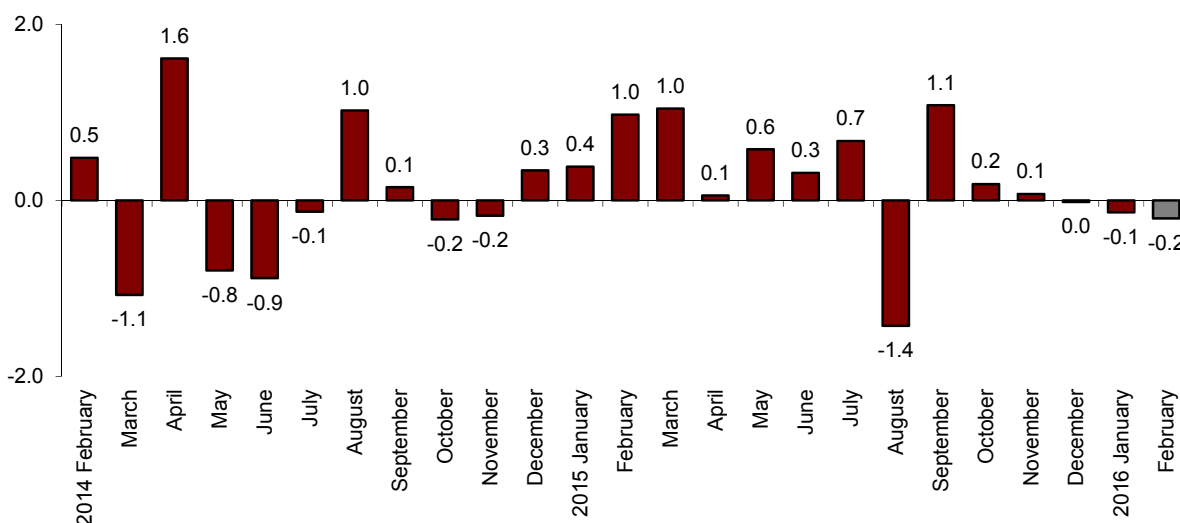
La variación mensual del Índice de Producción Industrial es del -0,2% si se eliminan los efectos estacionales y de calendario

La tasa anual del Índice de Producción Industrial se sitúa en el 2,2% en la serie corregida de efectos estacionales y de calendario, y en el 5,9% en la serie original

Evolución mensual de la producción industrial

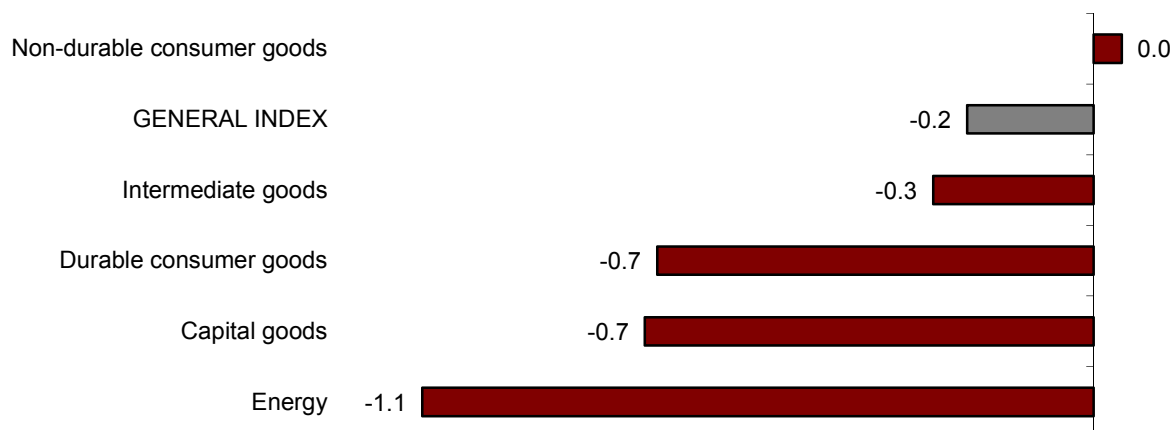
La variación mensual del Índice de Producción Industrial (IPI) entre los meses de febrero y enero, eliminando los efectos estacionales y de calendario, es del -0,2%. Esta tasa es 0,1 puntos inferior a la observada en enero.

Cuatro de los sectores analizados presentan tasas mensuales negativas. Energía (-1,1%) y, Bienes de equipo y Bienes de consumo duradero (ambos con -0,7%), registran las mayores bajadas.

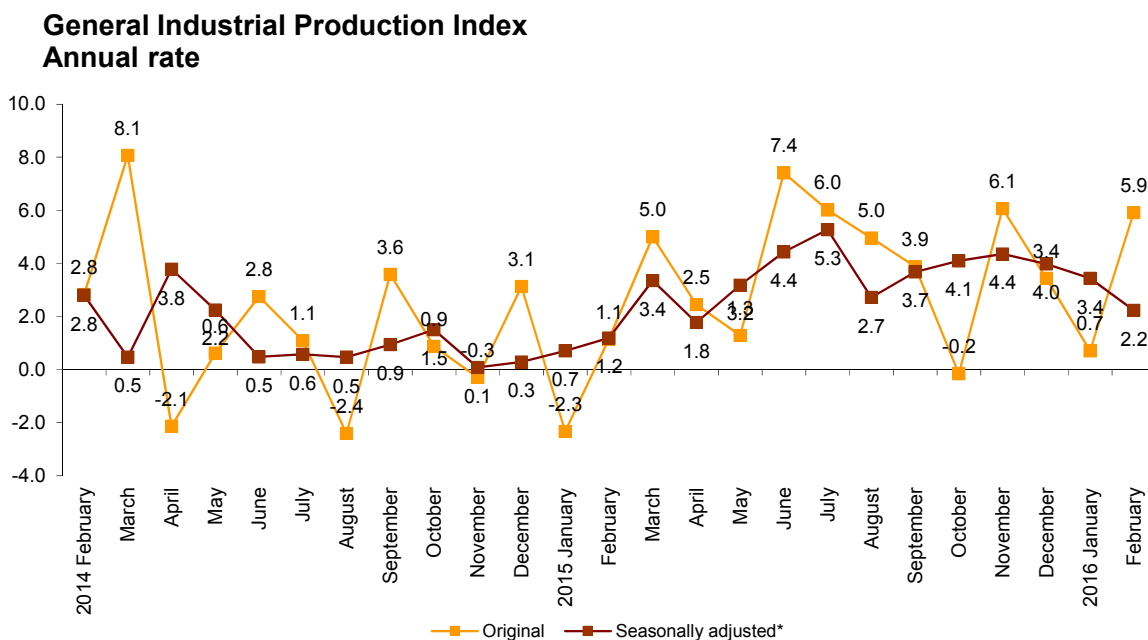

Evolución anual de la producción industrial

El Índice de Producción Industrial corregido de efectos estacionales y de calendario presenta en febrero una variación del 2,2% respecto al mismo mes del año anterior. Esta tasa es 1,2 puntos inferior a la registrada en enero.

La serie original del IPI experimenta una variación anual del 5,9%. Esta tasa es 5,2 puntos superior a la del mes de enero.



En datos corregidos de efectos estacionales y de calendario, Bienes de equipo (6,1%) y Bienes intermedios y Bienes de consumo no duradero (3,6% ambos) son los sectores que registran los mayores incrementos en tasa anual.

Por su parte, Energía (-8,0%) y Bienes de consumo duradero (-1,3%) presentan tasas anuales negativas.

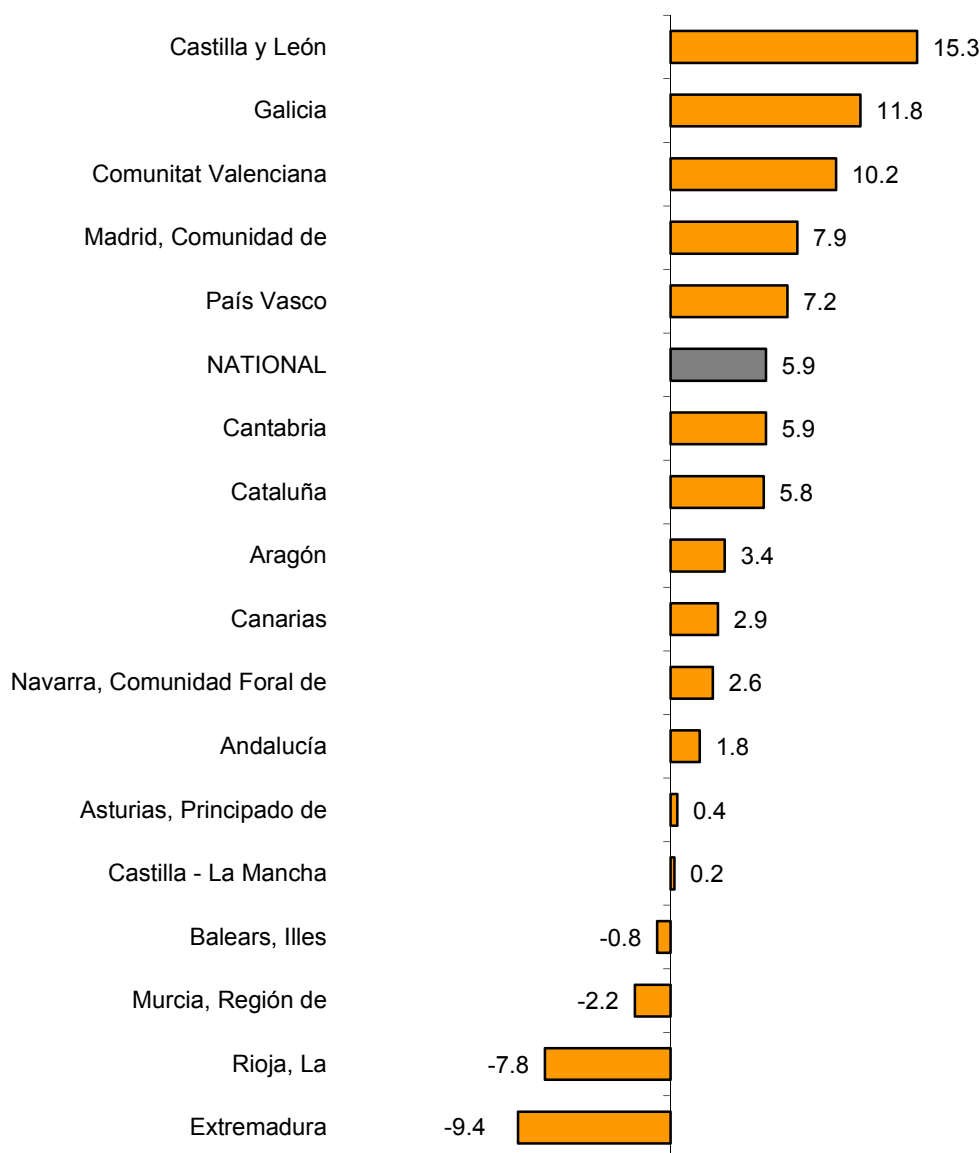

Resultados por comunidades autónomas. Tasas de variación anual de la producción industrial. Serie original

La tasa anual de la producción industrial aumenta en 13 comunidades autónomas. Los mayores incrementos se dan en Castilla y León (15,3%), Galicia (11,8%) y Comunitat Valenciana (10,2%).

Por su parte, las comunidades que presentan los mayores descensos en su tasa anual son Extremadura (-9,4%), La Rioja (-7,8%) y Región de Murcia (-2,2%).
