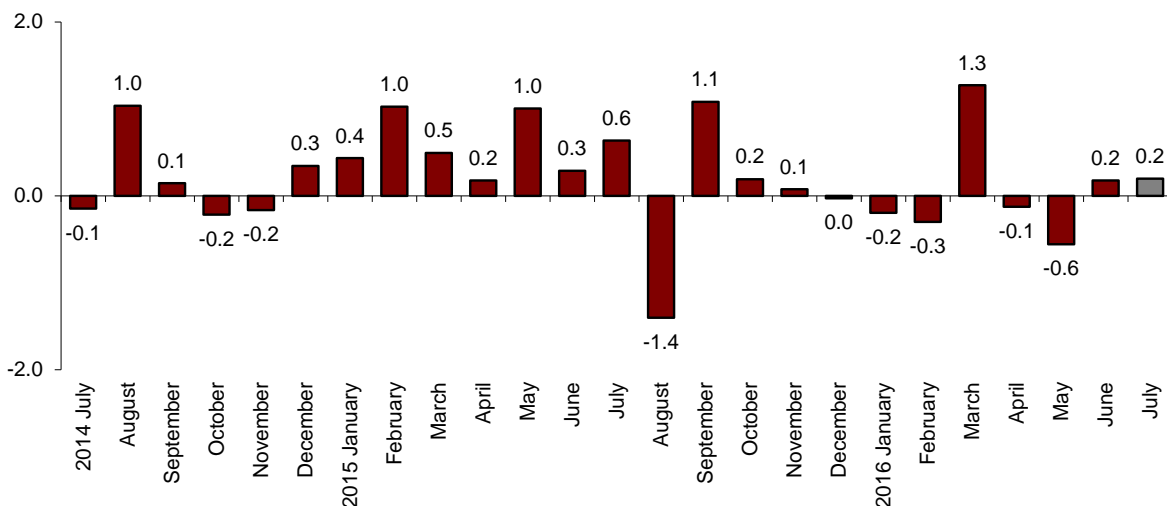
La variación mensual del Índice de Producción Industrial es del 0,2% si se eliminan los efectos estacionales y de calendario

La tasa anual del Índice de Producción Industrial se sitúa en el 0,3% en la serie corregida de efectos estacionales y de calendario, y en el -5,2% en la serie original

Evolución mensual de la producción industrial

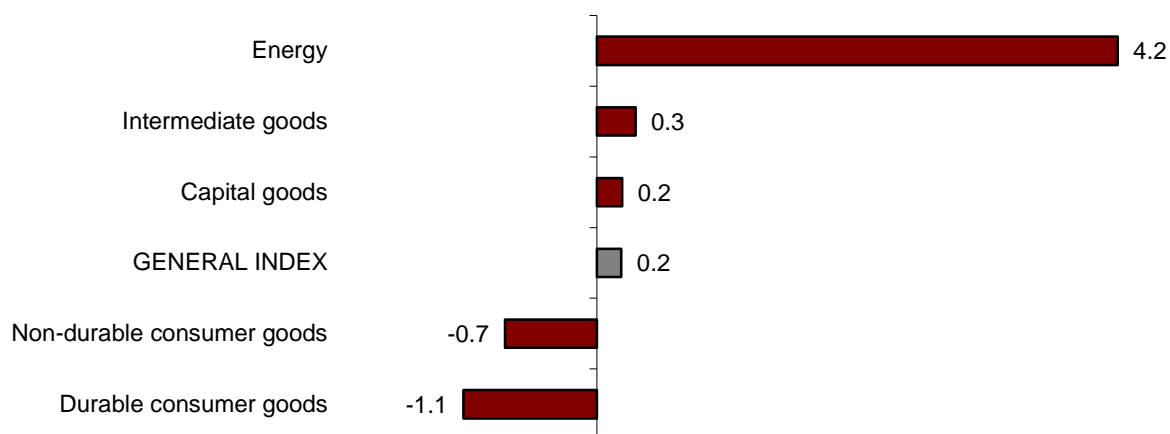
La variación mensual del Índice de Producción Industrial (IPI) entre los meses de julio y junio, eliminando los efectos estacionales y de calendario, es del 0,2%. Esta tasa es la misma que la observada en junio.

Los sectores Energía (4,2%), Bienes intermedios (0,3%) y Bienes de equipo (0,2%) presentan tasas mensuales positivas. Por su parte, Bienes de consumo duradero (-1,1%) y Bienes de consumo no duradero (-0,7%), registran variaciones negativas.

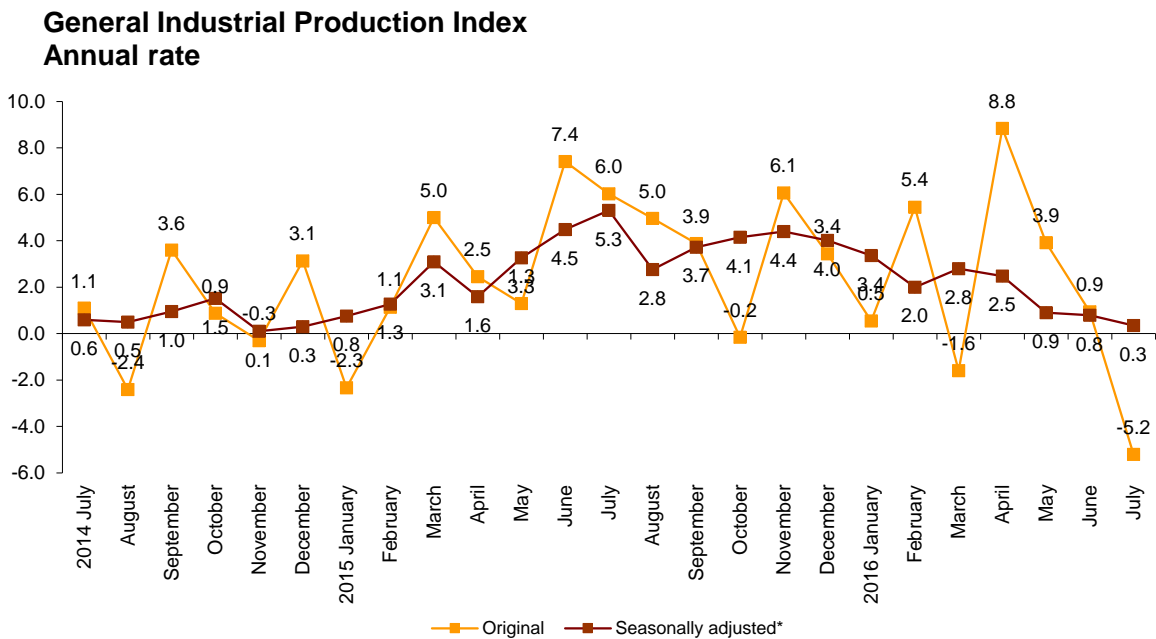

Evolución anual de la producción industrial

El Índice de Producción Industrial corregido de efectos estacionales y de calendario presenta en julio una variación del 0,3% respecto al mismo mes del año anterior. Esta tasa es 0,5 puntos inferior a la registrada en junio.

La serie original del IPI experimenta una variación anual del -5,2%. Esta tasa es 6,1 puntos inferior a la del mes de junio.



En datos corregidos de efectos estacionales y de calendario, Bienes intermedios (1,3%) y Bienes de consumo no duradero y Bienes de equipo (ambos con 1,1%) son los sectores que registran los mayores incrementos en tasa anual.

Por su parte, Energía (-2,7%) es el único sector con tasa anual negativa.

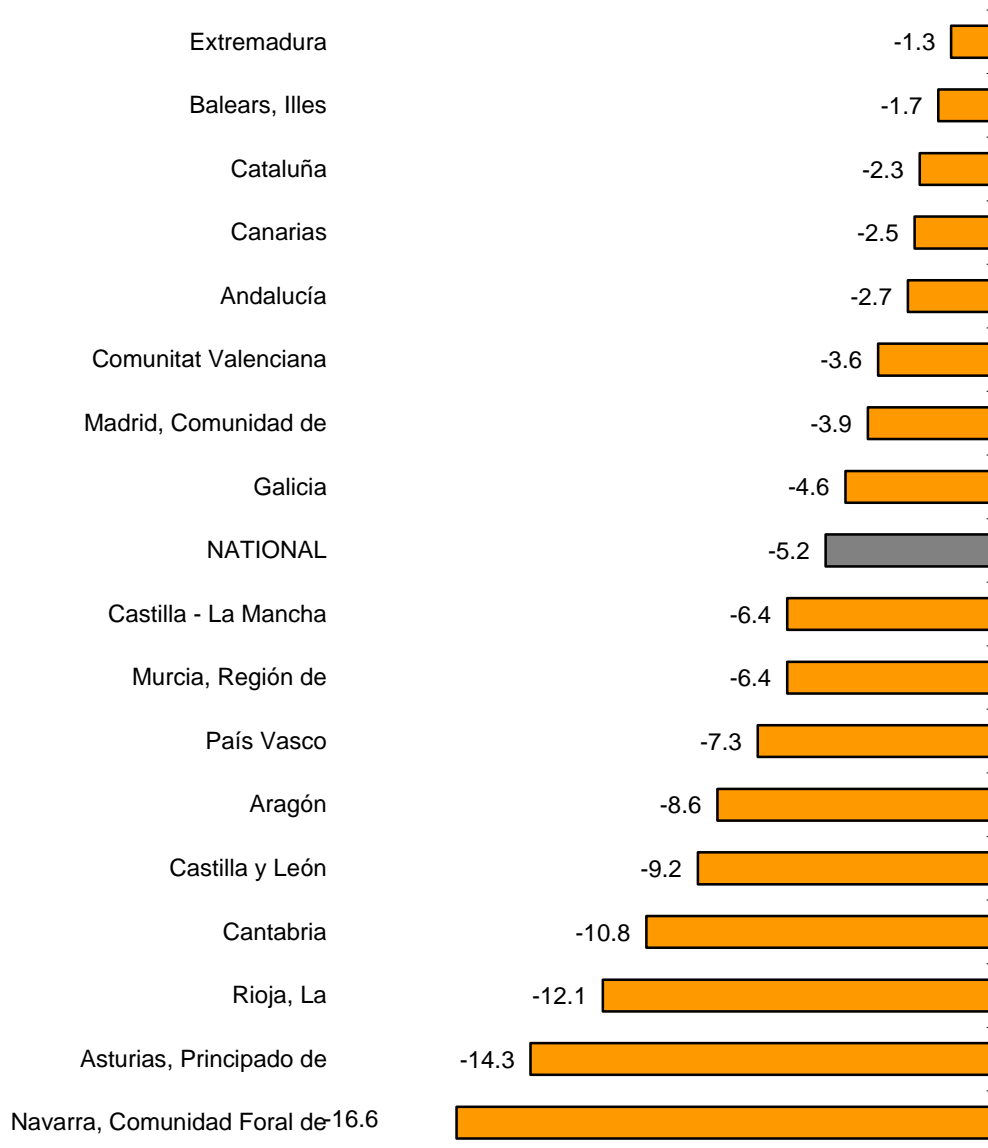

Resultados por comunidades autónomas. Tasas de variación anual de la producción industrial. Serie original

La tasa anual de la producción industrial es negativa en todas las comunidades autónomas.

Comunidad Foral de Navarra (-16,6%), Principado de Asturias (-14,3%) y La Rioja (-12,1%) presentan los mayores descensos.
