Mercantile Companies Statistics (MC) January 2018. Provisional data

In January 9,406 mercantile companies were created, 5.8% more than in the same month of 2017 and 3,708 were dissolved, 6.9% more

Principado de Asturias (27.3%), Extremadura (23.0%) and Cantabria (21.9%) are the Autonomous Communities with the greatest business dynamism¹

In January, 9,406 mercantile companies were created, 5.8% more than in the same month of 2017. The subscribed capital for their constitution exceeded 599 million euros, with an annual decrease of 25.9%. The average subscribed capital (63,761 euros) decreased by 30.0%.

On the other hand, 3,927 mercantile companies increased their capital in January, 3.6% less than in the same month of 2017. The capital subscribed in the increases recorded a 17.4% decrease and exceeded 3,181 million euros. The average capital subscribed in these transactions (810,219 euros) decreased 14.3% in annual rate.

The number of mercantile companies dissolved in January was 3,708, indicating 6.9% more than in the same month of 2017. Of these, 82.4% did so voluntarily, 10.4% due to mergers and the remaining 7.2% for other reasons.



Evolution of the monthly rate


In order to contribute to the analysis and interpretation of the data, the following chart shows the variation of the number of mercantile companies created and dissolved between December and January in the last five years. In 2018, the monthly variation of the number of companies created was 39.5% and that of the companies dissolved was 43.4%.


Performance of the monthly rate of mercantile companies created and dissolved (January 201 variation is compared with December 2017)




Results by main economic activity

Of the mercantile companies created in January, 21.5% corresponded to *Trade* and 15.4% to *Real estate, financial and insurance companies.* Regarding the dissolved companies, 22.5% corresponded to *Trade* and 15.0% to *Construction*.










The activity with the greatest net balance of mercantile companies created in the month of January 2018 was Trade, with 1,192.

Conversely, Administrative and support service activities presented the lowest net balance, with 133 companies created.




Net balance of mercantile companies created by main economic activity

The economic activity with the greatest subscribed capital of mercantile companies created was Real estate, financial and insurance, with 429.70 million euros.

In turn, Administrative and support service activities registered the lowest capital, with 3.04 million.

Results by Autonomous Community

Press Release

The Autonomous Communities with the greatest number of mercantile companies created in January were Comunidad de Madrid (1,989), Cataluña (1,748), and Andalucía (1,640).

Conversely, those with the lowest number of mercantile companies created were La Rioja (41), Cantabria (89) and Comunidad Foral de Navarra (94).

Regarding dissolved mercantile companies, the Autonomous Communities that registered the highest number of dissolutions were Comunidad de Madrid (1,109), Andalucía (505) and Comunitat Valenciana (323).

In turn, those with the lowest number of dissolutions were Comunidad Foral de Navarra (9), La Rioja (15) and Región de Murcia (32).




In terms of annual variation of the number of mercantile companies created, Principado de Asturias (27,3%), Extremadura (23.0%) and Cantabria (21,9%) were the Autonomous Communities with highest annual rates.

In turn, Canarias (-9.0%), La Rioja (-8.9%) and Región de Murcia (-8.1%) registered the largest decreases.

Regarding the mercantile companies dissolved, the highest rates were recorded in Castilla– La Mancha (91.7%), Comunidad de Madrid (17.1%) and La Rioja (15.4%).

In turn, those with the highest decreases were Comunidad Foral de Navarra (-43.8%), Región de Murcia (-17.9%) and Aragón (-15.6%).
