Mercantile Companies Statistics

March 2015. Provisional data

9,903 mercantile companies are created in March, 4.0% more than in the same month of 2014, and 1,781 are dissolved, 10.1% less

The Autonomous Communities with the greatest business dynamism¹ are Extremadura (35.8%), Principado de Asturias (29.9%) and Canarias (21.1%)

9,903 mercantile companies were created in March, that is, 4.0% more than in the same month of 2014. The capital subscribed for their constitution exceeded 619 million euros, representing an increase of 30.1%. The average capital subscribed (62,544 euros) increased 25.1% in its annual rate.

On the other hand, 3,099 mercantile companies increased their capital in March, 4.1% more than in the same month of 2014. The capital subscribed in the increases dropped by 67.9%, and exceeded 2,067 million euros. The average capital subscribed in these transactions (667,094 euros) decreased 69.2% in its annual rate.

The number of companies dissolved in March was 1,781, 10.1% less than in the same month of the previous year. Among these, 68.3% did so voluntarily, 8.0% due to mergers and the remaining 23.7% for other reasons.



Performance of the monthly rate


In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of mercantile companies created and dissolved between February and March in the last five years. In 2015, the monthly variation of the number of companies created was 13.7% and that of the companies dissolved was –14.0%.


Performance of the monthly rate of mercantile companies created and dissolved (variation of March over February of the same year)




Results by main economic activity

22.6% of the mercantile companies created in the month of March corresponded to *Trade* and 18.5% to *Construction*. Regarding the dissolved companies, 21.4% corresponded to *Trade* and 20.7% to *Construction*.






% mercantile companies dissolved by main economic activity. March 2015



The economic activity with the greatest net balance of mercantile companies created was *Trade*, with 1,861 new companies.

On the contrary, *Agriculture and fishing* registered the lowest net balance, with 192 companies created.


Net balance of mercantile companies created by main economic activity March 2015



The economic activity with the greatest capital subscribed of the mercantile companies created was *Accommodation and catering*, with 252.74 million euros.

In turn, *Administrative and support services activities* presented the lowest capital subscribed, with 3.33 million euros.

Results by Autonomous Communities

The Autonomous Communities with the greatest number of mercantile companies created in March were Comunidad de Madrid (1,958), Cataluña (1,840) and Andalucía (1,760).

Conversely, the Autonomous Communities where less mercantile companies were created were La Rioja (43), Comunidad Foral de Navarra (87) and Cantabria (95).

Regarding the dissolved mercantile companies, the Autonomous Communities that presented the highest number of dissolutions were Comunidad de Madrid (435), Andalucía (269) and Cataluña (220).

In turn, those with the lowest number of dissolutions were Comunidad Foral de Navarra (18), Extremadura (20) and Cantabria (22).



In terms of annual rates of the number of mercantile companies created, Extremadura (35.8%), Principado de Asturias (29.9%) and Canarias (21.1%) recorded the highest rates.

In turn, Comunidad Foral de Navarra (-17.1%), Galicia (-8.1%) and La Rioja (-6.5%) registered the greatest decreases.

Regarding the mercantile companies dissolved, La Rioja (31.6%), Canarias (29.2%) and Extremadura (5.3%) were the Autonomous Communities to register the highest positive rates.

In turn, the Autonomous Communities registering the lowest annual rates were País Vasco (-34.8%), Cantabria (-26.7%) and Comunitat Valenciana (-25.0%).
