Mercantile Companies Statistics (MC)

May 2015. Provisional data

8,063 mercantile companies are created in May, 1.9% less than in the same month of 2014, and 1,360 are dissolved, 5.5% less

The Autonomous Communities with the greatest business dynamism¹ are Cantabria (44.7%), Andalucía (7.5%) and Cataluña (7.0%)

8,063 mercantile companies were created in May, that is, 1.9% less than in the same month of 2014. The capital subscribed for their constitution exceeded 454 million euros, representing an increase of 17.0%. The average capital subscribed (56,401 euros) increased 19.3% in its annual rate.

On the other hand, 2,383 mercantile companies increased their capital in May, 10.6% less than in the same month of 2014. The capital subscribed in the increases decreased by 59.8%, and exceeded 3,383 million euros. The average capital subscribed in these transactions (1,419,747 euros) decreased 55.0% in its annual rate.

The number of companies dissolved in May was 1,360, that is, 5.5% less than in the same month of the previous year. Among these, 67.1% did so voluntarily, 5.6% due to mergers and the remaining 27.3% for other reasons.



Performance of the monthly rate


In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of mercantile companies created and dissolved between April and May in the last five years. In 2015, the monthly variation of the number of companies created was –2.7% and that of the companies dissolved was –5.0%.





Results by main economic activity

21.4% of the mercantile companies created in the month of May corresponded to *Trade* and 16.9% to *Construction*. Regarding the dissolved companies, 22.6% corresponded to *Trade* and 18.6% to *Construction*.

% mercantile companies created by main economic activity. May 2015








The economic activity with the greatest net balance of mercantile companies created in May 2015 was *Trade*, with 1,421 new companies.

On the contrary, *Transport and storage* registered the lowest net balance, with 218 companies created.


Net balance of mercantile companies created by main economic activity May 2015



The economic activity with the greatest capital subscribed of the mercantile companies created was *Real estate, financial and insurance activities,* with 301.35 million euros.

In turn, *Administrative and support services activities* presented the lowest capital subscribed, with 2.50 million euros.

Results by Autonomous Communities

The Autonomous Communities with the greatest number of mercantile companies created in May were Cataluña (1,707), Comunidad de Madrid (1,581) and Andalucía (1,355).

Conversely, the Autonomous Communities where less mercantile companies were created were La Rioja (42), Cantabria (68) and Comunidad Foral de Navarra (85).

Regarding the dissolved mercantile companies, the Autonomous Communities that presented the highest number of dissolutions were Comunidad de Madrid (324), Andalucía (219) and Cataluña (170).

In turn, those with the lowest number of dissolutions were Región de Murcia (six), Comunidad Foral de Navarra (11) and La Rioja (11).



In terms of annual variation of the number of mercantile companies created, Cantabria (44.7%), Andalucía (7.5%) and Cataluña (7.0%) recorded the highest rates.

In turn, Castilla-La Mancha (-29.2%), La Rioja (-27.6%) and Extremadura (-21.8%) registered the greatest decreases.

Regarding the mercantile companies dissolved, Illes Balears (67.4%), Comunidad de Madrid (16.1%) and Comunidad Foral de Navarra (10.0%) were the Autonomous Communities to register the highest positive rates.

In turn, the Autonomous Communities registering the lowest annual rates were Región de Murcia (-77.8%), Cantabria (-53.6%) and La Rioja (**-52.2%)**.
