## Mercantile Companies Statistics (MC)

June 2015. *Provisional data*

**8,254 mercantile companies are created in June, 9.6% more than in the same month of 2014, and 1,442 are dissolved, 0.9% more**

**The Autonomous Communities with the greatest business dynamism<sup>1</sup> are Cataluña (24.9%), Principado de Asturias (20.8%) and Extremadura (18.3%)**

8,254 mercantile companies were created in June, that is, 9.6% more than in the same month of 2014. The capital subscribed for their constitution exceeded 386 million euros, representing an increase of 8.6%. The average capital subscribed (46,815 euros) decreased 0.9% in its annual rate.

On the other hand, 2,550 mercantile companies increased their capital in June, 5.5% more than in the same month of 2014. The capital subscribed in the increases registered an increase of 15.7% and exceeded 2,934 million euros. The average capital subscribed in these transactions (1,150,940 euros) increased 9.7% in its annual rate.

The number of companies dissolved in June was 1,442, that is, 0.9% more than in the same month of 2014. Among these, 66.1% did so voluntarily, 8.0% due to mergers and the remaining 25.9 % for other reasons.

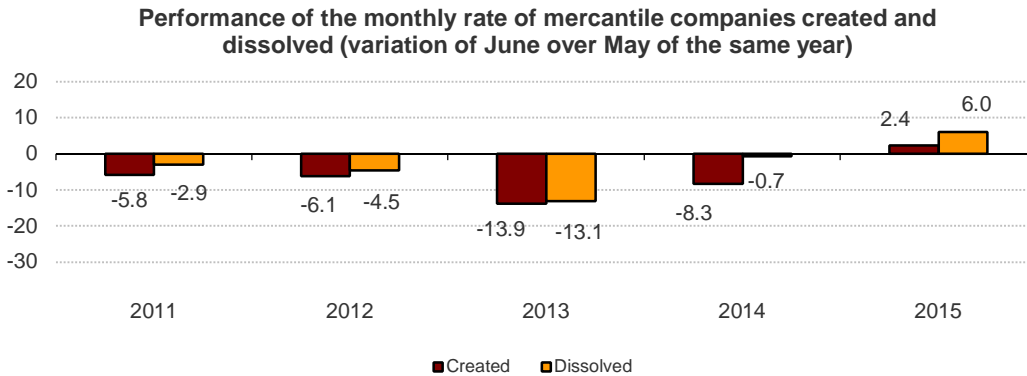

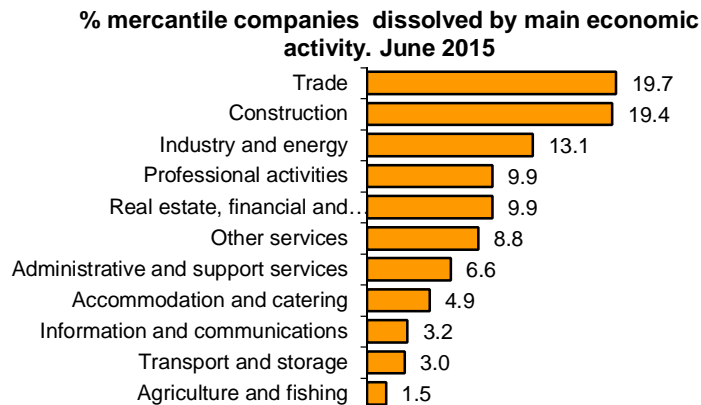
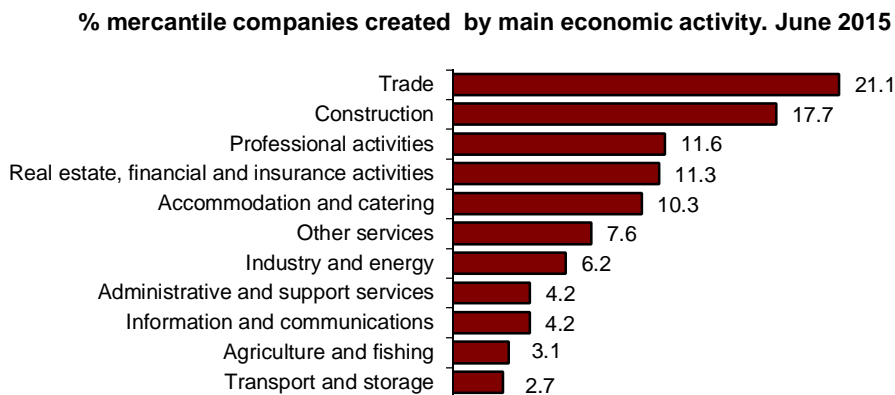
**Performance of the monthly rate**

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of mercantile companies created and dissolved between May and June in the last five years. In 2015, the monthly variation of the number of companies created was 2.4% and that of the companies dissolved was 6.0%.



**Results by main economic activity**

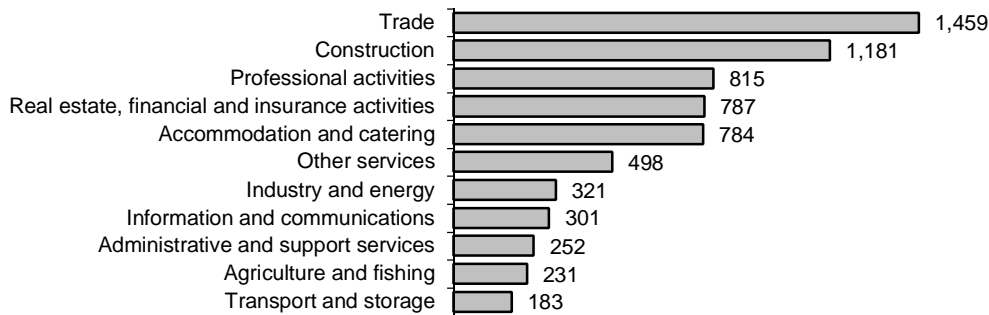
21.1% of the mercantile companies created in the month of June corresponded to *Trade* and 17.7% to *Construction*. Regarding the dissolved companies, 19.7% corresponded to *Trade* and 19.4% to *Construction*.



The activity with the greatest net balance of mercantile companies created in June 2015 was *Trade*, with 1,459 new companies.

On the contrary, *Transport and storage* registered the lowest net balance, with 183 companies created.

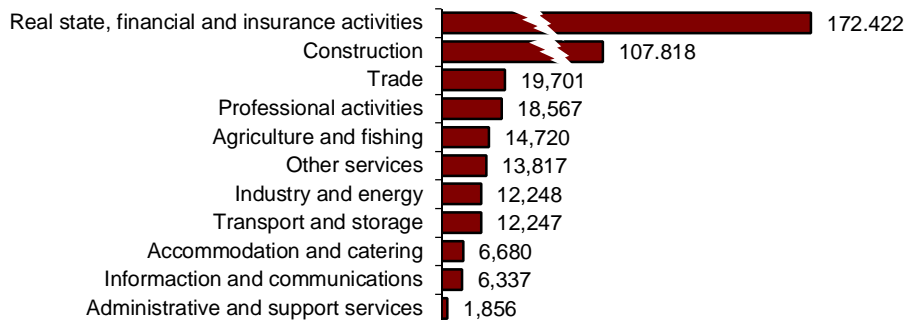
**Net balance of mercantile companies created by main economic activity

The economic activity with the greatest capital subscribed of the mercantile companies created was *Real estate, financial and insurance activities*, with 172.42 million euros.

In turn, *Administrative and support services activities* presented the lowest capital subscribed, with 1.86 million euros.

## Results by Autonomous Communities

The Autonomous Communities with the greatest number of mercantile companies created in June were Comunidad de Madrid (1,776), Cataluña (1,553), and Andalucía (1,440).

Conversely, the Autonomous Communities where less mercantile companies were created were La Rioja (28), Cantabria (79), Extremadura (95) and Comunidad Foral de Navarra (95).

Regarding the dissolved mercantile companies, the Autonomous Communities that presented the highest number of dissolutions were Comunidad de Madrid (396), Andalucía (184) and Cataluña (162).

In turn, those with the lowest number of dissolutions were Cantabria and La Rioja (both 11), Comunidad Foral de Navarra (14) and Extremadura (17).

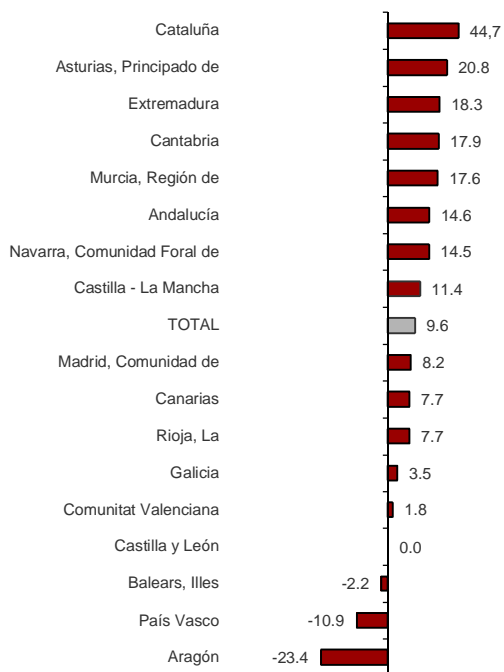
In terms of annual variation of the number of mercantile companies created, Cataluña (24.9%), Principado de Asturias (20.8%) and Extremadura (18.3%) recorded the highest rates.

In turn, Aragón (-23.4%), País Vasco (-10.9%) and Illes Balears (-2.2%) registered the greatest decreases.

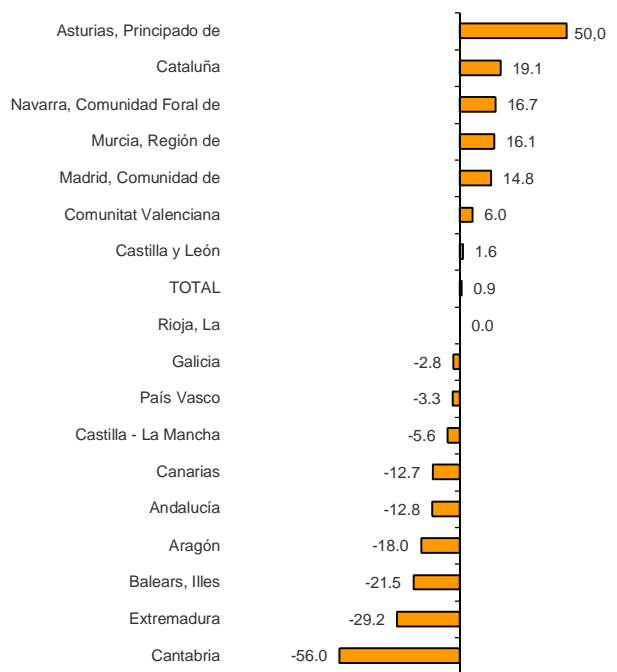
Regarding the mercantile companies dissolved, Principado de Asturias (50.0%), Cataluña (19.1%) and Comunidad Foral de Navarra (16.7%) were the Autonomous Communities to register the highest positive rates.

In turn, the Autonomous Communities registering the lowest annual rates were Cantabria (-56.0%), Extremadura (-29.2%) and Illes Balears (-21.5%).
