Mercantile Companies Statistics (MC)

October 2016. Provisional data

7,129 mercantile companies were created in October, 4.2% less than in the same month of 2015, and 1,543 were dissolved, 0.9% more than in September 2015

The Autonomous Communities with the greatest business dynamism¹ are Galicia (20.6%), Principado de Asturias (17.8%) and Illes Balears (12.5%)

7,129 mercantile companies were created in October, that is, 4.2% less than in the same month of 2015. The capital subscribed for their constitution exceeded 718 million euros, representing an increase of 20.5%. The average capital subscribed (100,724 euros) increased 25.9% in its annual rate.

On the other hand, 2,180 mercantile companies increased their capital in October, 10.9% less than in the same month of 2015. The capital subscribed in the increases registered a decrease of 40.4% and exceeded 1,774 million euros. The average capital subscribed in these transactions (814,045 euros) decreased 33.1% in its annual rate.

The number of companies dissolved in October was 1,543, that is, 0.9% more than in the same month of 2015. Among these, 67.9% did so voluntarily, 12.8% due to mergers and the remaining 19.3% for other reasons.



Performance of the monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of mercantile companies created and dissolved between September and October in the last five years. In 2016, the monthly variation of the number of companies created was 26.3% and that of the companies dissolved was 5.1%.


Performance of the monthly rate of mercantile companies created and dissolved (October 2016 variation is compared with September 2016)




Results by main economic activity

22.7% of the mercantile companies created in the month of October corresponded to *Trade* and 13.7% to *Construction*. Regarding the dissolved companies, 21.1% corresponded to *Trade* and 16.5% to *Construction*.






% mercantile companies dissolved by main economic activity. October 2016




The activity with the greatest net balance of mercantile companies created in October 2016 was *Trade*, with 1,290 new companies.


On the contrary, *Agriculture and fishing* registered the lowest net balance, with 167 companies created.



The economic activity with the greatest capital subscribed of the mercantile companies created was *Real estate, financial and insurance activities*, with 574.42 million euros.

In turn, *Information and communications* presented the lowest capital subscribed, with 3.30 million euros.





Results by Autonomous Communities

The Autonomous Communities with the greatest number of mercantile companies created in October were Comunidad de Madrid (1,625), Cataluña (1,428), and Andalucía (1,196).

Conversely, the Autonomous Communities where less mercantile companies were created were La Rioja (28), Comunidad Foral de Navarra (57) and Cantabria (66).

Regarding the dissolved mercantile companies, the Autonomous Communities that presented the highest number of dissolutions were Comunidad de Madrid (493), Andalucía (220) and Cataluña (148).

In turn, those with the lowest number of dissolutions were Comunidad Foral de Navarra and La Rioja (both with 12) and Extremadura (16).



In terms of annual variation of the number of mercantile companies created, Galicia (20.6%), Principado de Asturias (17.8%) and Illes Balears (12.5%) recorded the highest rates.

In turn, Castilla y León (-25.0%), País Vasco (-19.3%) and Región de Murcia (-16.9%) registered the greatest decreases.

Regarding the mercantile companies dissolved, Principado de Asturias (70.0%), Comunitat Valenciana (24.4%) and Andalucía (14.6%) were the Autonomous Communities that registered the highest positive rates.

In turn, the Autonomous Communities registering the lowest annual rates were Castilla–La Mancha (–46.2%), Extremadura (–38.5%) and Región de Murcia (–29.2%).
