Mercantile Companies Statistics

December 2013 and Year 2013. Provisional data

6,986 mercantile companies are created in December, 10.9% more than in the same month of the previous year, and 2,397 are dissolved, 3.3% less

The Autonomous Communities with the greatest business dynamism¹ are Cantabria (48.0%), Comunidad Foral de Navarra (32.7%) and País Vasco (32.0%)

6,986 mercantile companies were created in December, 10.9% more than in the same month of 2012. The capital subscribed for their constitution exceeded 416 million euros, representing a decrease of 33.1%. The average capital subscribed (59,598 euros) fell 39.7% in its annual rate.

On the other hand, 2,575 mercantile companies increased their capital in December, 7.7% less than in the same month of 2012. The capital subscribed in the increases registered an interannual decrease of 64.9%, and exceeded 3,103 million euros. The average capital subscribed in these transactions (1,205,182 euros) decreased 62.0% in its annual rate.

The number of companies dissolved in December was 2,397, indicating an interannual decrease of 3.3%, as compared with the same month of the previous year. Of these, 73.4% did so voluntarily, 9.9% due to mergers and the remaining 16.7% for other reasons.



Evolution of the monthly rate



In order to contribute to the analysis and interpretation of the data, the following chart shows the variation of the number of mercantile companies created and dissolved between November and December in the last five years. In December 2013, the monthly variation of the number of companies created was -5.0% and that of the companies dissolved was 11.7%.




Results by main economic activity

22.5% of the mercantile companies created in the month of December corresponded to *Trade* and 16.2% to *Construction*. Regarding the dissolved companies by economic activity, 22.5% corresponded to *Construction* and 21.2% to *Trade*.



The economic activity with greatest net balance of all the mercantile companies created was *Trade*, with 1,062 companies. *Administrative and support service activities* registered the lowest net balance, with 96 companies created.


Net balance of mercantile companies created by main economic activity





The economic activity with the greatest capital subscribed of the mercantile companies created is *Real state, financial and insurance activities,* with 268.59 million euros. *Administrative and support service activities* presented the lowest capital subscribed, with 1.68 million.





Results by Autonomous City and Community

The Autonomous Communities with the greatest number of mercantile companies created were Comunidad de Madrid (1,443) and Cataluña (1,371). Conversely, the Autonomous Communities where less mercantile companies were created were La Rioja (30) and Comunidad Foral de Navarra (73).

Regarding the dissolved mercantile companies, the Autonomous Communities that presented the highest number of dissolutions were Comunidad de Madrid (512) and Andalucía (357). In turn, the Autonomous Communities with the lowest number of dissolutions were Comunidad Foral de Navarra (16) and Región de Murcia (21).



In terms of annual rates of mercantile companies created, Cantabria (48.0%), Comunidad Foral de Navarra (32.7%) and País Vasco (32.0%) registered the greatest increases.

In turn, La Rioja (21.1%), Aragón (–15.9%) and Región de Murcia (–13.7%) were the Autonomous Communities with negative annual rates.

Regarding the mercantile companies dissolved in December, Comunidad Foral de Navarra (77.8%) and Región de Murcia (40.0%) recorded the greatest annual rates. Conversely, the lowest rates was registered in Extremadura (–52.6%) and País Vasco (–28.7%).


93,363 mercantile companies were created in 2013, that is, 7.1% more than in 2012. The capital subscribed for their constitution decreased 12.0%, while the average capital subscribed registered an interannual decrease of 17.8%.


On the other hand, in 2013, a total of 34,630 mercantile companies increased their capital, 5.4% less than in 2012. The capital subscribed in the increases registered an interannual increase of 26.2% and the average capital subscribed recorded an interannual increase of 33.4%.

The number of companies dissolved in 2013 was 24,735, that was 9.1% more than in 2012.




Results by main economic activity in 2013

22.5% of the mercantile companies created in 2013 corresponded to *Trade* and 18.9% to *Construction*.

Regarding the companies dissolved by main economic activity, 22.7% corresponded to *Construction* and 20.3% to *Trade*.

Results by Autonomous City and Community in 2013

In 2013, the Autonomous Communities with the greatest number of mercantile companies created were Comunidad de Madrid (19,657) and Cataluña (17,708).

Conversely, the Autonomous Communities where less mercantile companies were created were La Rioja (410) and Cantabria (798).


Regarding the dissolved mercantile companies, the Autonomous Communities that presented the highest number of dissolutions were Comunidad de Madrid (5,617) and Andalucía (3,679). In turn, the Autonomous Communities with the lowest number of dissolutions were Comunidad Foral de Navarra (181) and La Rioja (248).

In 2013, the Autonomous Communities with the greatest average capital subscribed by mercantile companies created were País Vasco (108,010 euros) and Comunidad de Madrid (101,039).

Conversely, those with a lower average capital were Extremadura (27,833 euros) and Castilla-La Mancha (37,341).
