Unpaid Bills of Exchange Statistics (UBE)

August 2014. Provisional data

The value of unpaid bills of exchange decreases 28.1% in August, as compared with the same month of 2013

2.0% of the total expired bills of exchange are unpaid


In August, the value of the expired bills of exchange reached 11,816 million euros, 7.4% less than that registered in the same month of 2013.


With regards to returned unpaid bills of exchange, the value reached 239 million euros, representing a 28.1% annual decrease.

The percentage of unpaid bills of exchange as compared with expired bills of exchange reached 2.0%, that is, a similar value to that registered in the two previous months and six tenths below that registered in the same month of the previous year.





In August, the total value of expired bills of exchange reached 6,689,988, that is, 2.2% less than in the same month of 2013.

The average value of expired bills of exchange reached 1,766 euros, representing a 5,3% decrease in the annual rate. In turn, the average value of unpaid bills of exchange stood at 1,230 euros, that is, 15.5% less than that registered in August 2013.





Monthly rate evolution

In order to contribute to the analysis and interpretation of data, this chart shows the variation in the value of the unpaid and expired bills of exchange between August and July in the last five years.

In August 2014, the monthly variation of the expired bills of exchange decreased 14.2%, and the monthly variation of the unpaid bills of exchange did so by 13.9%.





Credit expired by type of bill

In August, 62.0% of the value of expired bills of exchange corresponded to unpaid portfolio bills of exchange and 38.0% to debt collection management from clients.

Of the total value of unpaid bills of exchange, 63.4% corresponded to portfolio bills of exchange and 36.6% to bills of exchange in debt collection management.

In August, 2.1% of the total expired portfolio bills of exchange were unpaid. Likewise, 1.9% of the total expired bills of exchange in debt collection management were unpaid.



Geographical distribution of unpaid bills of exchange

In August, the greatest annual decreases of the value of unpaid bills of exchange were registered in Región de Murcia (–50.0%), Cantabria (–40.1%) and Extremadura (–39.4%). In turn, the only annual increase was registered in Galicia (2.0%).

Annual variation value of unpaid bills of exchange by Autonomous Community. August 2014



Canarias (2.8%) and Extremadura (2.5%) was the Autonomous Community that presented the highest percentage of unpaid bills of exchange as compared with the expired bills of exchange. In turn, Comunidad Foral de Navarra (1.6%) registered the lowest percentage.

In August, Cataluña and Comunidad de Madrid accumulated around half of the total of unpaid bills of exchange (51.6%).
