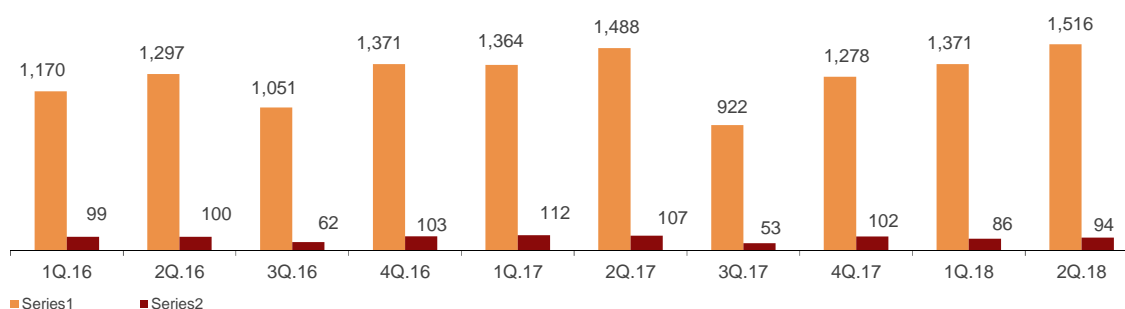
**The number of bankrupt debtors increases its annual rate by 0.9%
in the second quarter of 2018**

**37.9% of the companies declared bankrupt have as their main
activity *Trade and Construction***

During the second quarter of 2018, the number of bankrupt debtors reached 1,610 representing a 0.9% increase, as compared with the same period of the previous year.

By type of bankruptcy, 1,516 were voluntary (1.9% more than the second quarter of 2017) and 94 were necessary (12.1% less). Considering the type of procedure, ordinary procedures decreased 10.0%, and abbreviated procedures did so by 2.7%.

Evolution of the number of debtors processed¹



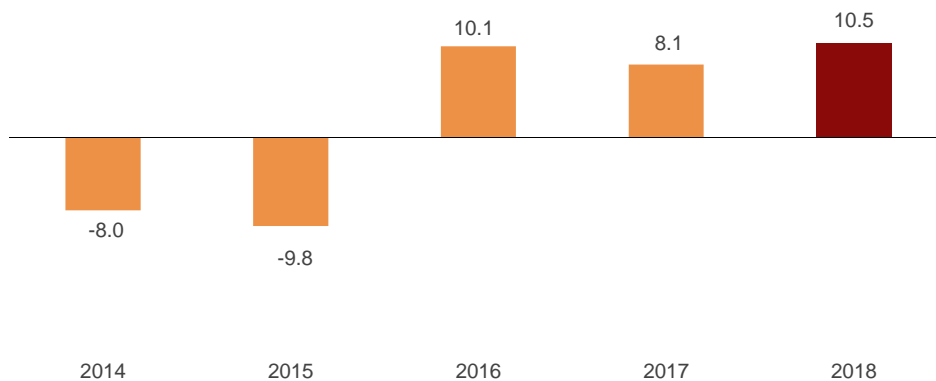

Evolution of the quarterly rate

To contribute to the analysis and interpretation of the data, the following chart shows the quarterly variation of the number of bankrupt debtors between the second and the first quarter in the last five years. In 2018 the quarterly rate was 10.5%, the highest for the period in question.

Companies declared bankrupt, by legal nature and turnover bracket

Within the 1,610 bankrupt debtors in the second quarter, 1,200 were companies (individuals with business activity and corporations), and 410 were individuals without business activities, representing 74.5% and 25.5%, respectively of the total debtors.

In the second quarter of 2018, the number of bankrupt companies decreased by 1.2%, as compared with the same period of the previous year.

By legal nature, 81.8% of companies declared bankrupt were Private Limited Companies.

38.3% of companies declared bankrupt were within the lowest turnover bracket (up to 250,000 euros) and were mainly Private Limited Companies.

Companies declared bankrupt by economic activity and number of employees

Of the companies declared bankrupt 21.3% have *Trade* as their main business activity, 16.6% have *Construction* and 15.3% have *Other Services*.

Regarding the number of employees, 60.1% of the total number of companies declared bankrupt had less than six. Among these, 33.1% had no employees.

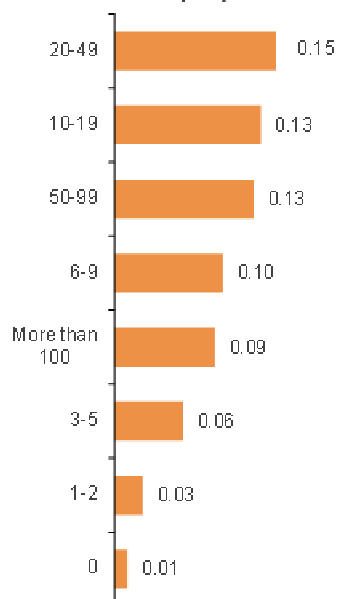

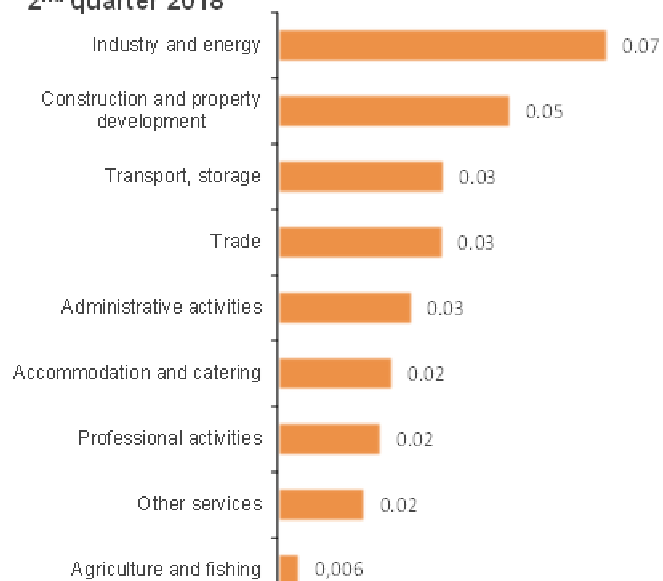
Taking the total number of existing companies in each economic activity as a reference, 0.07% of the *Industry and energy* companies initiated a bankruptcy proceeding during the second quarter, as compared with 0.005% of the *Agriculture and fishing* companies.

By employee bracket, 0.15% of existing companies with 20-49 employees initiated a bankruptcy proceeding, as compared with 0.01% of companies without employees.

Bankrupt companies by seniority

Of the total number of bankrupt companies processed during the first quarter, 18.9% had a seniority of 20 years or over. In turn, 21.9% were four years old or younger.

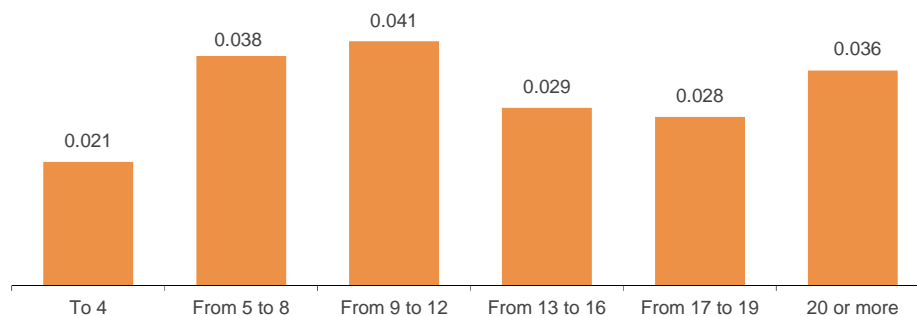
23.6% of bankrupt companies with four or less years of experience were in the *Trade* sector. On the other hand, 53.7% of bankrupt companies with 20 or more years of experience were involved in *Trade*, and in *Industry and energy*.

Taking the stock of existing companies by seniority as a reference, 0.036% of those that were 20 years old or more were affected by a bankruptcy proceeding this quarter. However, 0.021% of total companies with up to four years old initiated a bankruptcy proceeding.

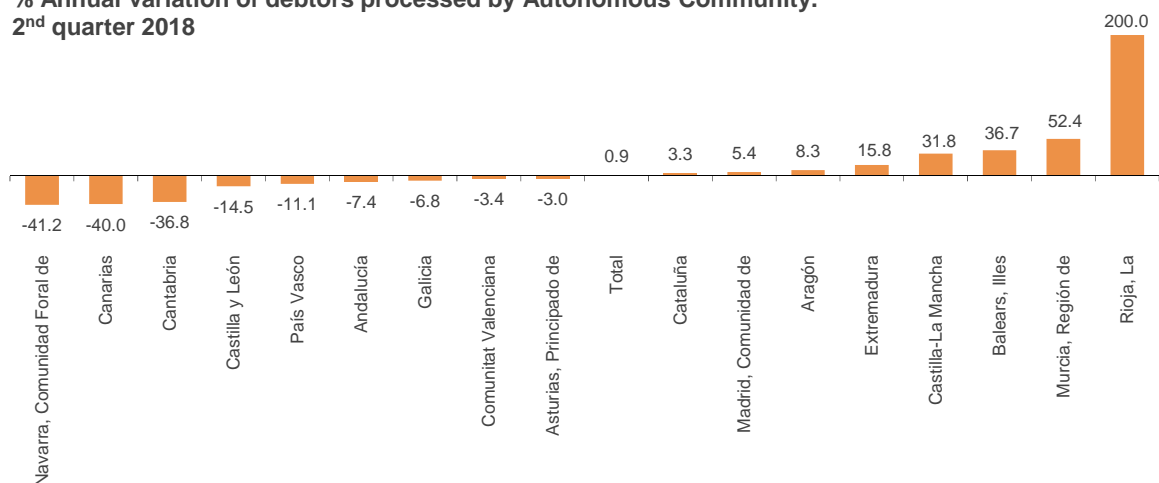
Cataluña and Comunidad de Madrid accounted for 45.0% of the bankrupt debtors during the second quarter of 2018.

In terms of annual variation of the number of bankrupt debtors, Comunidad Foral de Navarra was the Autonomous Community with the highest decrease (-41.2%). In turn, La Rioja registered the highest increase (200.0%).
