Bankruptcy Proceedings Statistics (BPS)

Third quarter 2014. Provisional data


The number of debtors processed decreases its annual rate by 28.8% in the third quarter of 2014

Construction and Trade accounted for 41.2% of the total of debtors processed

During the third quarter of 2014, the number of debtors processed reached 1,401, representing a 28.8% decrease, as compared with the same period of the previous year.

By type of bankruptcy, 1,313 were voluntary (29.8% less than in the third quarter of 2013) and 88 were necessary (9.3% less). Considering the type of procedure, ordinary procedures decreased 27.9%, and abbreviated procedures did so by 29.0%.



Evolution of the quarterly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the quarterly variation of the number of debtors processed between the third and the second quarter of the same year during the last five years. In 2014, the quarterly rate was –25.1%.



Companies declared bankrupt, by legal nature and turnover bracket

Within the 1,401 debtors processed in the this quarter, 1,270 were companies (individuals with business activity and corporations), and 131 were individuals without business activities, representing 90.6% and 9.4%, respectively, of the total debtors.

In the third quarter of 2014, the number of companies processed decreased 29.5%, as compared with the same period of the previous year.

By legal nature, 80.5% of the companies processed were Private Limited Companies.

29.1% of the companies processed were within the lowest turnover bracket (up to 250,000) and were, mainly, Private Limited Companies.

Companies declared bankrupt, by economic activity and number of employees

21.7% of the companies declared bankrupt carried out their main activity in *Construction*, 19.5% in *Trade* and 16.1% in *Industry and energy*.


Regarding the number of employees, 65.4% of the total number of companies declared bankrupt had less than 10 employees. Within these, 22.9% had zero employees.



Taking the total number of existing companies in each economic activity as a reference, it is worth noting that 0.10% of the *Industry and energy* companies initiated a bankruptcy proceeding during the third quarter. In turn, only 0.02% of the *Professional activities* companies were affected by bankruptcy proceedings.

By employee bracket, 0.34% of the companies with 50-99 employees started a bankruptcy proceeding, as compared with 0.01% of the companies without employees that were affected by bankruptcy proceedings.





Companies declared bankrupt, by seniority

22.0% of the total number of companies processed during the third quarter had a seniority of 20 years or over. In turn, 14.4% had a seniority of four years or less.

Within the companies declared bankrupt with a seniority of less than four years, 24.0% carried out their main activity in *Trade*. In turn, within the companies declared bankrupt with seniority of 20 years or over, 59.1% carried out their main activity in *Trade* and in *Industry* and energy.

Taking as a reference the stock of existing companies by seniority, 0.05% of the companies of 20 years or over were affected by a bankruptcy proceeding this quarter. However, 0.02% of the total companies with up to four years of seniority started a bankruptcy proceeding.

Geographical distribution of debtors processed


The Autonomous Communities of Cataluña, Comunitat Valenciana and Comunidad de Madrid accounted for 51.5% of the total debtors processed during the third quarter of 2014.

The Autonomous Community that registered the greatest decrease in the number of bankrupt debtors considering the annual variation rate was Canarias (-63.2%).

In turn, Aragón (1.7%) was the only Autonomous Community representing positive annual variation rate.
