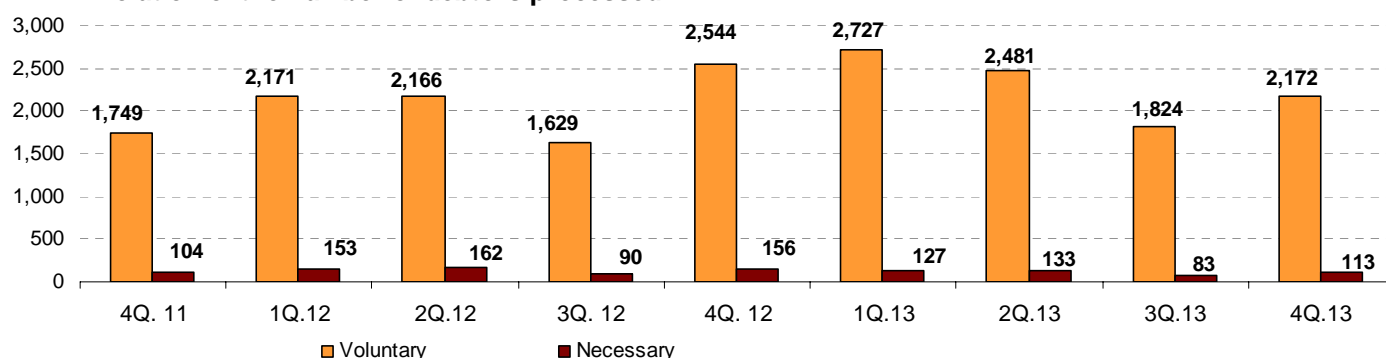
**The number of debtors processed decreases 15.4% in the annual rate in the fourth quarter 2013**

**25.9% of companies processed in the fourth quarter 2013 had *Construction* as their main activity**

In the fourth quarter 2013, the number of debtors processed reached 2,285, representing a 15.4% decrease, as compared with the same quarter of 2012.

By type of bankruptcy, the voluntary type decreased 14.6% and the necessary did so by 27.6%. By type of proceeding, abbreviated proceedings decreased 8.4% and ordinary proceedings did so by 36.7%.

**Evolution of the number of debtors processed\***



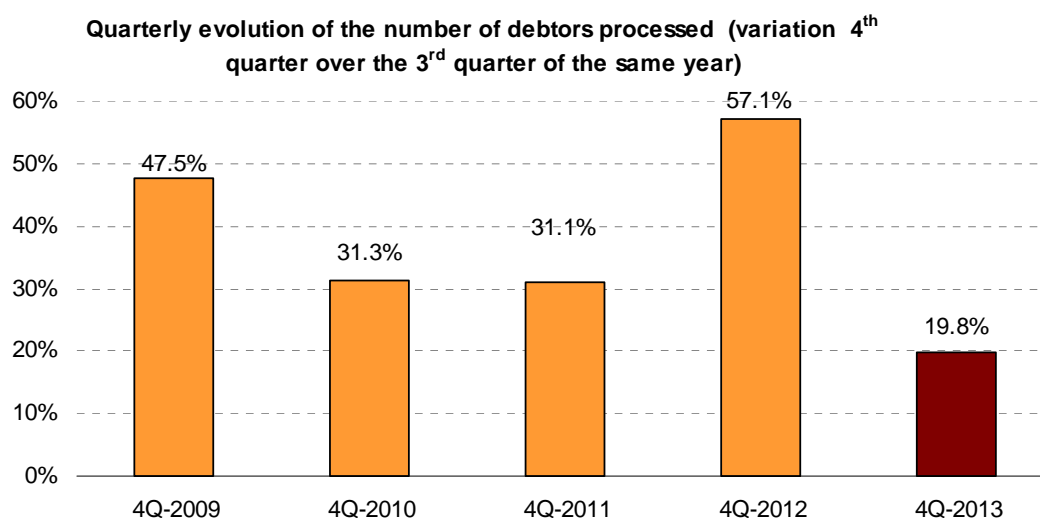

## Evolution of the quarterly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the quarterly variation of the number of bankrupt debtors between the fourth and the third quarter of the last five years. In 2013, the quarterly rate was 19.8%, the lowest of the last five years.



## Processed companies by legal nature and turnover bracket

Of the 2,285 bankrupt debtors in the fourth quarter, 2,116 were companies (individuals with a business activity and legal persons) and 169 were individuals without a business activity, representing 92.6% and 7.4%, respectively, of the total number of debtors.

The number of companies declared bankrupt decreased 13.1% in the fourth quarter, as compared with the same quarter of 2012.

According to the legal nature, 77.3% of the companies declared bankrupt were Private Limited Companies.

25.4% of the companies declared bankrupt were within the lowest turnover bracket (up to 250,000 euros) and were, mainly, Private Limited Companies.

### Companies declared bankrupt by economic activity and number of employees

25.9% of the companies processed had *Construction* as their main economic activity, 19.8% had *Trade*, and 16.9% *Industry and energy*.

Regarding the number of employees, 74.1% of the total companies declared bankrupt had less than 20. And, among these, 38.2% had less than three employees.

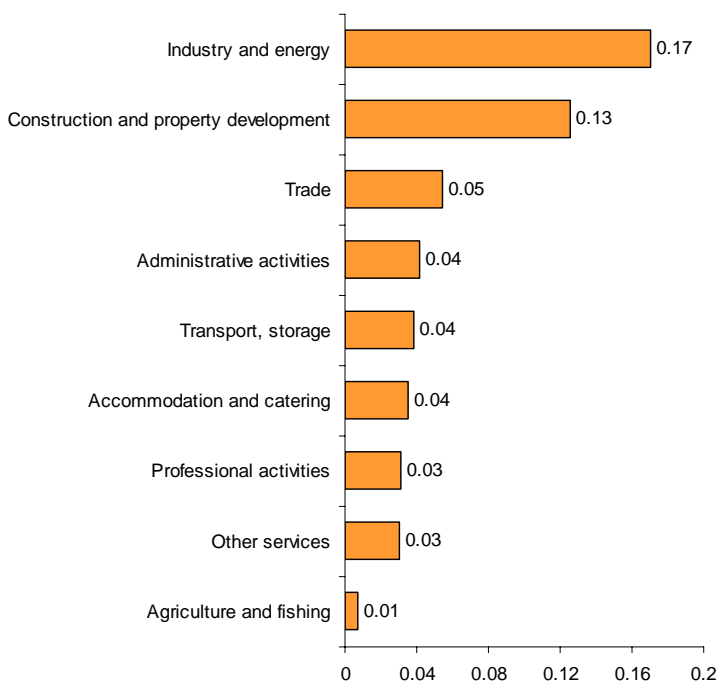

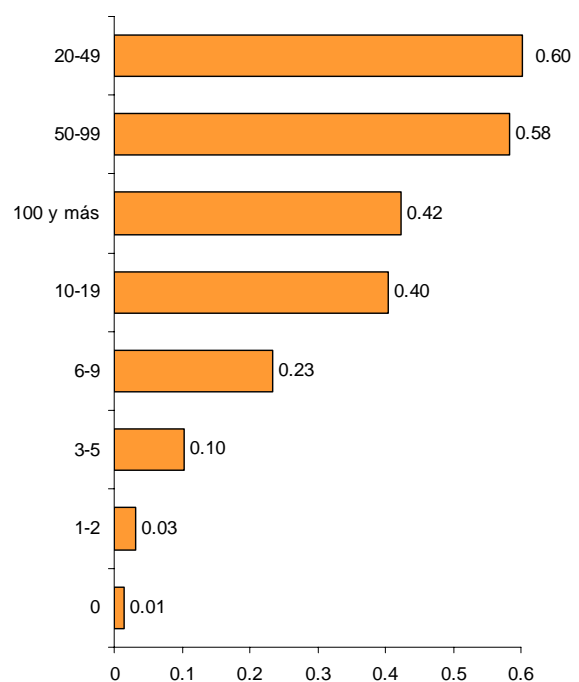
Taking the total of companies existing in each economic activity as a reference, 0.17% of the companies in *Industry and energy* started a bankruptcy proceeding in the fourth quarter of 2013, as compared with 0.01% of the companies in *Agriculture, livestock and fishing*.

Taking into account the number of the companies existing by employee bracket, 0.60% of the companies with 20-49 employees started a bankruptcy proceeding, whereas only 0.01% of the companies without employees were affected by bankruptcy proceedings.

### Companies declared bankrupt by seniority

25.5% of the total of companies processed in the fourth quarter of 2013 had 20 years or over seniority. In turn, 12.8% had four or less years of seniority.

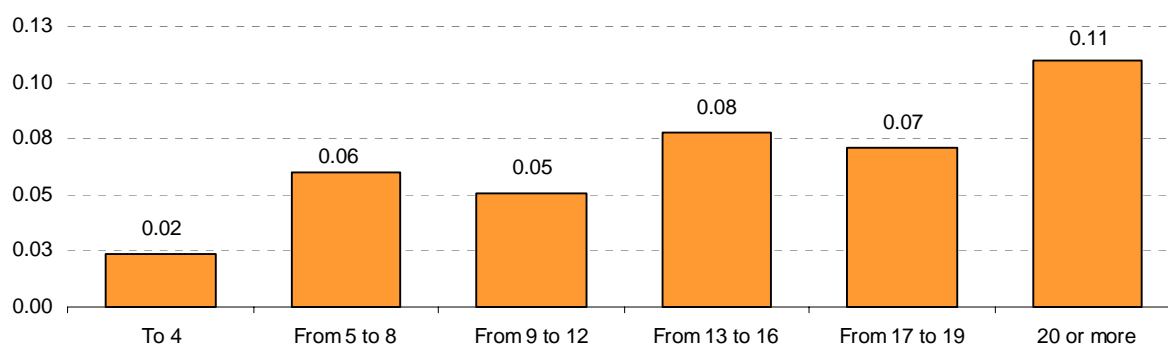
Out of the companies processed with less than four years of seniority, 41.9% were dedicated to *Trade* and *Construction*. However, within the companies processed with 20 or more years of seniority, 59.4% were dedicated to *Industry and energy* and *Trade*.

Taking as a reference the stock of companies existing by seniority, 0.11% of the companies of 20 years or over were affected by a bankruptcy proceeding. However, 0.02% of the total companies with up to 4 years of seniority started a bankruptcy proceeding.

### Geographical distribution of debtors processed

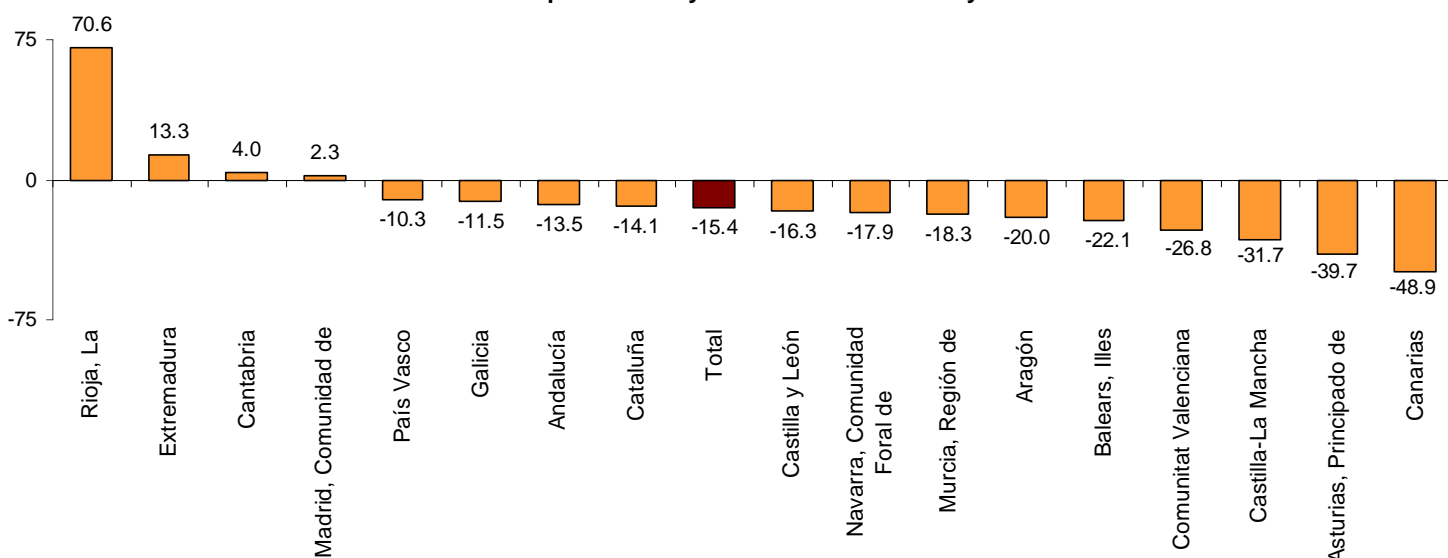
The Autonomous Communities of Cataluña, Comunidad de Madrid and Comunitat Valenciana amounted to 52.2% of the total bankrupt debtors in the fourth quarter of 2013.

The Autonomous Community that registered the greatest decrease in the number of bankrupt debtors considering the annual variation rate was Canarias (-48.9%). In turn, La Rioja (70.6%) registered the greatest annual variation rate.

**% Annual variation of debtors processed by Autonomous Community**

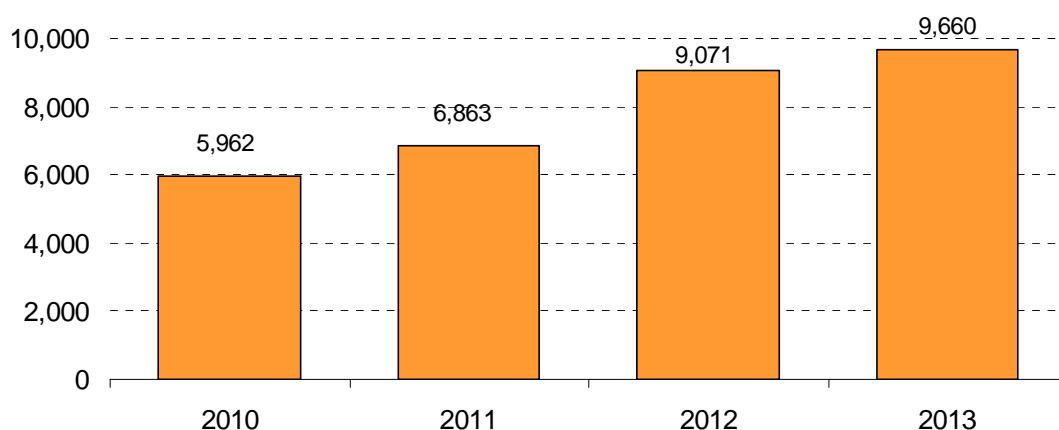


### Annual results: 2013

The number of bankrupt debtors all over 2013 was 9,660, a 6.5% higher than that registered in 2012.

By type of proceeding, 9,204 were voluntary (8.2% more than in 2012) and 456 were necessary (18.7% less). Considering the type of proceedings, ordinary proceedings increased 13.6% and abbreviated proceedings did so by 4.5%.

### Processed companies by legal nature and turnover bracket

Considering the legal nature, 77.5% of the companies declared bankrupt in 2013 were Public Limited Companies.

27.1% of the companies declared bankrupt were within the lowest turnover bracket (up to 250,000 euros) and were, mainly, Private Limited Companies.

### Companies declared bankrupt by main economic activity

92.5% of the bankrupt debtors processed in 2013 were companies (individuals with a business activity and legal persons).

By activities, *Construction, Trade and Industry and energy* registered 62.4% of the total number of companies declared bankrupt in 2013.

The *Administrative activities* (60.6%) and *Professional activities* (51.5%) represented the greatest increases of processed companies in 2013, as compared with the previous year. In turn, *Transport and storage* (-17.7%) and *Construction* (-4.4%) recorded the greatest decreases.

### Companies declared bankrupt by economic activity and seniority

25.3% of the total of companies processed in 2013 had a seniority of 20 years or over. In turn, 11.6% had four or less years of seniority.

The economic activity with the greatest percentage of companies declared bankrupt with a seniority of 20 years or over was *Industry and Energy* (32.9%).

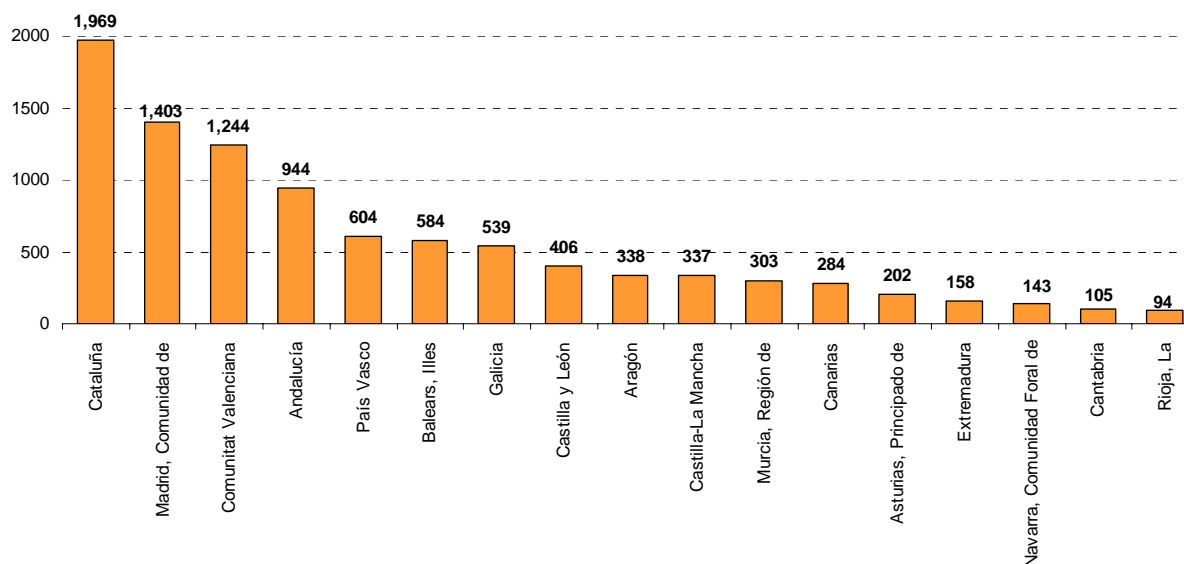

**Results by Autonomous Community**

Cataluña was the Autonomous Community registering the greatest number of processed debtors (1,969) in 2013, followed by Comunidad de Madrid (1,403) and Comunitat Valenciana (1,244). These three Autonomous Communities represented 47.8% of the total numbers of debtors processed.

The Autonomous Community with the lowest number of debtors processed was La Rioja (94).

Note: In October, November and December, the response rate of the courts was 97.8%, that is, out of the 89 courts to which the questionnaire was sent, there were 2 every month that did not submit information by the closing date of the statistics.
