
# Quarterly Labour Cost Survey (QLCS) First quarter of 2013

#### Main results

- The labour cost of companies decreases 1.4% in the first quarter of 2013, as compared with the same period of the previous year, standing at 2,480.22 euros per worker.
- The wage cost per worker per month decreases 1.8%, reaching 1,809.22 euros on average. In turn, other costs decrease 0.3%, standing at 671.00 euros per worker per month.
- -The working day decreases 3.5%. This quarter, 7.2 working hours per week are lost on average, 80% of which are a result of holidays taken and public holidays, due to the fact that Easter Week is held primarily in this quarter.
- As a consequence of the working day drop, the labour cost per effective hour worked increases 2.1%.
- In order to contribute to the analysis and interpretation of the data, as of this quarter the INE provides the main calendar- and seasonally-adjusted QLCS series. Considering these adjusted results, labour cost per worker decreases 1.1% in its annual rate, and labour cost per effective hour falls 0.4%.

#### Labour cost by component

The labour cost per worker per month reached 2,480.22 euros for the first quarter of 2013, indicating a decrease of 1.4%, as compared with the same period of the previous year. This is the second lowest rate since this survey is conducted.



Of the total cost, 1,809.22 euros corresponded to wages and 574.38 euros to obligatory Social Security contributions. The remainder corresponded to compensation for dismissal, social benefits, etc.

The wage cost, which comprised base salary, wage supplements, overtime payments, extraordinary payments and delayed payments, measured in gross terms, decreased by 1.8% in annual rate and reached 1,809.22 euros per worker per month. If the variable factor is excluded from wages (extraordinary and delayed payments), the ordinary wage cost is obtained, which decreased 0.5%.

Other costs (non-wage costs) decreased by 0.3%. Their main component, obligatory Social Security contributions, maintains its rate as in the first quarter 2012, whereas non-wage payments decreased 11.0%, due to the drop in all its components.

The labour cost per hour increased 2.1%. This increase, higher than that of cost per worker, is due to the drop in the number of effective working hours by 3.5% as a consequence of the Holly Week.

#### Labour cost by economic sector

*Industry* is the only sector showing increases in total labour cost and its main components. Worth noting in this sector the increase of ordinary wages and extraordinary payments. The increase of the other costs is, in particular, due to the growth of the obligatory Social Security contributions.

Construction showed a decrease in wage cost as a consequence of the maintenance of the ordinary wage cost, the drop of extraordinary payments and late payments —which represents a slight reduction of the total wage costs— and the decrease of the other costs due to the drop of the compensation for dismissal.

Sector *Services* decreased its labour costs due to the drop in wage cost –in particular extraordinary payments and late payments- and in other costs because of the decrease in non-wage payments.

By activity sections, it was observed that the increase of the labour cost was higher in Arts, entertainment and recreation, *Extractive Industries, Electricity, gas, steam and air conditioning supply.* 

Conversely in *financial and insurance Activities*, Human health and social work activities and real estate activities registered the most important decreases.





#### **Labour cost by Autonomous Community**

The labour cost in Comunidad de Madrid and País Vasco surpassed the national average by more than 300 euros. In Extremadura, Canarias and Castilla y León said labour cost was lower than the national average by the same amount.

Considering the interannual growth of this cost, País Vasco, Galicia and Illes Balears presented the highest rates, whereas Extremadura, Castilla y León and Castilla-La Mancha registered the less decreases.




#### Working time

During the fourth quarter of 2013, the average agreed working week, considering full-time and part-time together, was 34.5 hours. Among them, an average of 4.1 hours were lost per week, most of them due to holidays taken.

After adding overtime and subtracting hours lost, the working week was reduced to 30.5 effective hours worked.

#### Hours not worked



According to the **type of working day**, the wage difference between full and part-time workers was 4.39 euros per hour (14.17 euros/hour for full-time and 9.78 euros/hour for part-time).

Regarding the time worked, full-time workers practically doubled the effective hours worked by part-time workers (34.2 hours per week as compared with 17.4 hours).



#### Calendar- and seasonally-adjusted QLCS series

In order to contribute to the analysis and interpretation of the data, as of this quarter the main calendar- and seasonally-adjusted QLCS series are provided.

The labour cost per worker calendar- and seasonally-adjusted decreased 1.1% of the annual rate.


#### Annual evolution of the labour cost per worker



#### Performance of the quarterly rate

The variation rate in the first quarter of 2013, as compared with the fourth quarter of 2012, as of the calendar- and seasonally-adjusted QLCS series, increased 2.3% of the labour cost and 2.7% of the wage cost.
