#### **Quarterly Labour Cost Survey (QLCS)**


Third quarter of 2015

#### Main results

- The labour cost of companies increases 0.3% in the third quarter of 2015, as compared to the same period of 2014, standing at 2,456.46 euros per worker per month.
- The wage cost per worker per month increases by 0.5%, standing at an average of 1,809.88 euros. In turn, other costs decrease by 0.5%, standing at 646.58 euros per worker and per month.
- -During the third quarter of 2015, the average agreed working week is 34.8 hours, considering together full-time and part-time. Among them, an average of 6.9 hours per week are lost, (4.8 of them due to holiday periods).
- The labour cost per effective hour worked decreases 0.4% in the annual rate as a consequence of the higher number of hours worked.
- In the quarterly rate, and considering the results adjusted for seasonal and calendar effects, the wage cost per worker stays stable (0.0% rate) and the wage cost per effective hour worked decreases by 0.2%.
- Regarding the seasonally and calendar adjusted data, the wage cost per worker increases 0.4% in the third quarter of 2015, as compared to the same period of 2014, and the cost per effective hour worked increases 0.1%.
- In the third quarter of 2015, the number of vacancies is 62,172. 86.6% is registered in the *Services* sector.

#### Labour cost by component

The labour cost per worker per month reached 2,456.46 euros in the third quarter of 2015, indicating an increase of 0.3% as compared to the same period of the previous year.



Of the total cost per worker per month incurred by an employer in use of the work factor, 1,809.88 euros corresponded to wages, and 591.18 to compulsory Social Security contributions. The remainder corresponded to compensation for dismissal, social benefits, etc.

The wage cost (comprising base salary, wage supplements, overtime payments, extraordinary payments and delayed payments, measured in gross terms) increased by 0.5% in its annual rate, going from 1,800.46 euros to 1,809.88 euros per worker per month. Excluding the variable factor in wages (extraordinary and delayed payments), ordinary wage costs are obtained, which increased by 0.2%.

Other costs (non-wage costs) decreased 0.5%. Their main component, compulsory Social Security contributions, increased by 1.0%. Worth noting is the decrease of non-salary payments (7.3%), due to the decrease of compensation for dismissal, partial unemployment, and direct social benefits (Supplementary Social Security benefits paid by the employer).

The labour cost per hour decreased 0.4%. This decrease, as compared to the increase of the cost per worker, is due to the increase in the number of effective working hours. After adjusting this and the calendar effect, the estimated increase of the cost per hour is 0.1%.

#### Labour cost according to economic sectors

Services registered the greatest increase in total labour cost and wage cost this quarter. It is also worth noting the growth in this sector of ordinary wage costs and the stability of other costs level, due to the increase of obligatory Social Security contributions and a lower decrease of direct social benefits.

*Industry* registered the greatest decrease in total labour cost and in other costs, due to the decrease in non-wage payments.

In *Construction* all the components of the labour cost registered a decrease, except ordinary wages.


By activity sectors, it was observed that the highest increases of the labour cost were registered in *Electricity, gas, steam and air conditioning supply, Real Estate activities*, and *Financial and insurance activities*.

In turn, Arts, entertainment and recreation activities, Other services, and Wholesale and retail trade; repair of motor vehicles and motorcycles registered the greatest decreases.




#### **Labour cost by Autonomous Community**

The labour cost in País Vasco and Comunidad de Madrid surpassed the national average by more than 400 euros. In Extremadura and Canarias this labour cost was lower than the national average by the same quantity.

Considering the annual growth of this cost, La Rioja, Comunitat Valenciana and Aragón registered the highest growth rates, whereas Castilla-La Mancha, Comunidad Foral de Navarra, and País Vasco registered the highest decreases.




#### Working time

During the third quarter of 2015, the average agreed working week, considering full-time and part-time together, was 34.8 hours. Among them, an average of 6.9 hours were lost per week, most of them due to holiday periods (4.8 hours).

After adding overtime and subtracting lost hours, the working week was reduced to 28.0 effective hours worked this quarter.

#### Non-worked hours



According to the type of working day, the wage difference between full and part-time workers was 5.38 euros per hour (15.67 euros/hour for full-time and 10.29 euros/hour for part-time).

Regarding the time worked, the effective hours worked for full-time workers were 30.9, as compared to 18.1 effective hours worked for part-time workers.



#### Calendar and seasonally adjusted series

In order to contribute to the analysis and interpretation of the data, the main QLCS series are provided for the whole economy, adjusted for seasonal and calendar effects<sup>1</sup>.

Between the third quarter of 2015 and the second quarter, the total labour costs did not vary, after adjusting for seasonal and calendar effects.


#### Total labour cost per worker. Quarterly variation rates after adjusting for seasonal and calendar effects

#### Annual evolution of the labour cost per worker

The total labour cost per worker recorded an annual rate of 0.4%, after adjusting for seasonal and calendar effects.



#### **Vacancies**

The number of vacancies stood at 62,172 in the third quarter 2015. Out of the total, 86.6% were registered in *Services* sector.

Most of the units inquired answered that they do not have vacancies to cover this quarter because they do not need additional workers.

#### **Vacancies by Autonomous Community**

The Autonomous Communities registering the greatest number of vacancies in the third quarter of 2015 were Comunidad de Madrid, Cataluña and Andalucía. In turn, those recording the lowest number were Cantabria, La Rioja and Comunidad Foral de Navarra.

Considering the percent distribution, Comunidad de Madrid, Cataluña and Andalucía covered more than half of the total vacancies in this quarter.
