Statistics on Transfer of Property Rights (STPR) June 2014. Provisional data


In June, the number of property transfers registered is 125,817 properties, that is, 8.8% less than in the same month of the previous year

The merchanting of registered dwellings increases 8.8%, as compared with June 2013

The number of property transfers **recorded in the land registries (from public deeds previously registered)** was 125,817 in June, that is, 8.8% less than in the same month of 2013.

Regarding the merchanting of registered properties, the number of transfers was 56,250, representing an annual increase of 5.9%.

¹ "Other titles" includes land consolidation, horizontal divisions, joint ventures or mixtures of several titles transmission, transmissions without title of acquisition, non recourse debt, foreclosures and court awards.

Merchanting recorded in the land registries

83.3% of the registered merchanting in June corresponded to urban properties and 16.7% to rustic properties. Among the urban properties, 55.6% were merchanting of dwellings.

The number of merchanting of rustic properties increased by 10.3% in the annual rate in June, and that of urban properties did so by 5.0%. Within the later, merchanting of dwellings recorded an annual variation of 8.8%.



Evolution of the monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation in the number of merchantings of dwellings between the months of May and June of the last five years. In 2014, the monthly rate was -7.3%.

Registered merchanting on dwellings, by protection system and status

90.5% of transfers of dwellings by merchanting in June were free housing, and 9.5% were protected housing.

In annual terms, the number of transfers of free dwellings by merchanting increased by 9.9%, and that of protected dwellings decreased by 1.4%.


37.7% of the dwellings transferred by merchanting in June were new, and 62.3% were used.

The number of transactions on new dwellings decreased 3.0%, and the number of used dwellings increased 17.4%, as compared with June 2013.

Results by Autonomous Community

In June 2014, the total number of property transfers recorded in the land registries per 100,000 inhabitants² reached its highest value in the Autonomous Communities of Comunidad Foral de Navarra (566), Aragón (536) and Castilla y León (512).

The Autonomous Communities which registered the greatest annual variations were Comunidad Foral de Navarra (27.1%), Illes Balears (11.4%) and País Vasco (10.9%).

In turn, the Autonomous Communities that registered the lowest annual rates were Castilla-La Mancha (-26.3%), Cantabria (-23.9%) and Castilla y León (-17.9%).


Regarding the merchanting on registered dwellings, the Autonomous Communities with the highest number of transfers per 100,000 inhabitants² were Comunitat Valenciana (96), Canarias (87) and Illes Balears (81).

²This data was calculated from the provisional data of the Population Figures at 1 January 2014. Only the population aged 18 to 84 years old was considered.

The Autonomous Communities showing the greatest annual variation rates in the merchanting of dwellings in June were Comunidad de Madrid (30.4%), Extremadura (25.7%) and Comunidad Foral de Navarra (19.3%).

In turn, those showing the greatest decreases were Castilla-La Mancha (-21.6%), La Rioja (-12.8%) and Castilla y León (-10.3%).
