
**The monthly variation of turnover for the market Services Sector is 0.6% after adjusting for seasonal and calendar effects**

**The annual rate of turnover stands at 1.8% in the seasonally and calendar adjusted series and at 1.0% in the original series**

**Monthly evolution of the turnover for the market Services Sector**

The monthly variation of the general index of the turnover for the market Services Sector between August and July 2014 was 0.6%, after adjusting for seasonally and calendar effects. This rate was three tenths higher than that registered in July.


**General index of the turnover for the Market Services Sector

Trade registered a monthly variation of 0.8% and the variation of Other services was 0.4%, after adjusting for seasonal and calendar effects.

All sectors registered positive monthly rates, except for *Professional, scientific and technical activities* (−1.3%), *Information and communications* (−0.5%), and *Administrative and support service activities* (−0.3%). The greatest increases were recorded in *Retail trade* (2.9%), and *Sale and repair of motor vehicles and motorcycles* (2.3%).

A more detailed analysis showed the activities that registered the highest monthly rates and those that registered the greatest decreases in August.



### Annual turnover evolution rates for the Market Services sector

In August, the general Index of the turnover for the Market Services sector, after adjusting for seasonal and calendar effects, registered a variation of 1.8%, as compared with the same month of 2013. This rate was one tenth below that registered in July.

The original series registered an annual variation of 1.0%, that is, one point and four tenths below that recorded in July.

After adjusting for seasonal and calendar effects, Trade increased by 2.2% and Other services did so by 1.6%, as compared with the same month of the previous year.

By sectors, *Sale and repair of motor vehicles and motorcycles* (10.9%), and *Accommodation* (6.1%) registered the greatest increases. *Professional, scientific and technical activities* recorded the greatest decrease (-4.6%).



**Results by Autonomous Community. Annual turnover variation rates. Original series.**

In August, 11 Autonomous Communities registered an increase in their turnover in the Market Service Sector. The greatest increases were recorded in Canarias (5.6%), Andalucía (3.9%), and Illes Balears (3.2%).

In turn, Castilla y León (-1.2%), Castilla-La Mancha (-0.9%), and Aragón (-0.6%) registered the greatest decreases.

## Evolution of employed personnel

Employment in the Market Services Sector experienced an increase of 1.7% in August, as compared with the same month of the previous year. This annual rate was one tenth below that registered in July.

Employment increased 0.9% in the annual rate in Trade and 2.3% in Other services.


