La variación mensual de la cifra de negocios¹ del Sector Servicios de Mercado es del 0,5% si se eliminan los efectos estacionales y de calendario

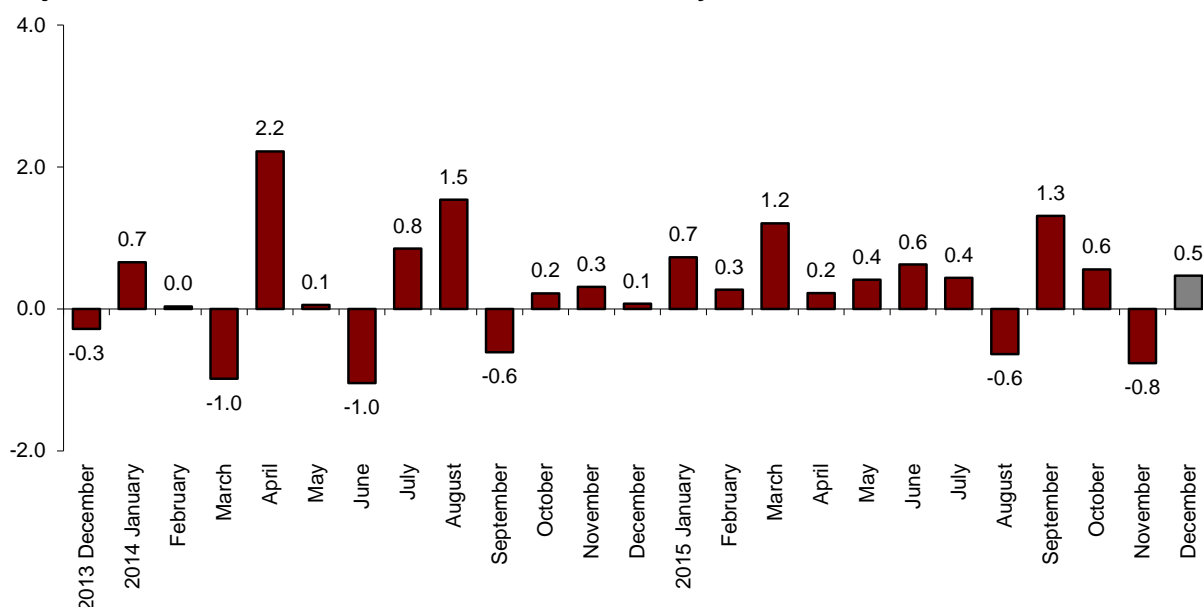
La tasa anual se sitúa en el 4,9% en la serie corregida de efectos estacionales y de calendario, y en el 4,6% en la serie original

En el conjunto de 2015 la cifra de negocios aumentó un 4,7% tanto en la serie corregida como en la original

Evolución mensual de la cifra de negocios del Sector Servicios de Mercado

La variación mensual del índice general de la cifra de negocios del Sector Servicios de Mercado entre diciembre y noviembre de 2015, eliminando los efectos estacionales y de calendario, es del 0,5%. Esta tasa es 1,3 puntos superior a la de noviembre.

Adjusted for seasonal and calendar effects. Monthly rate**



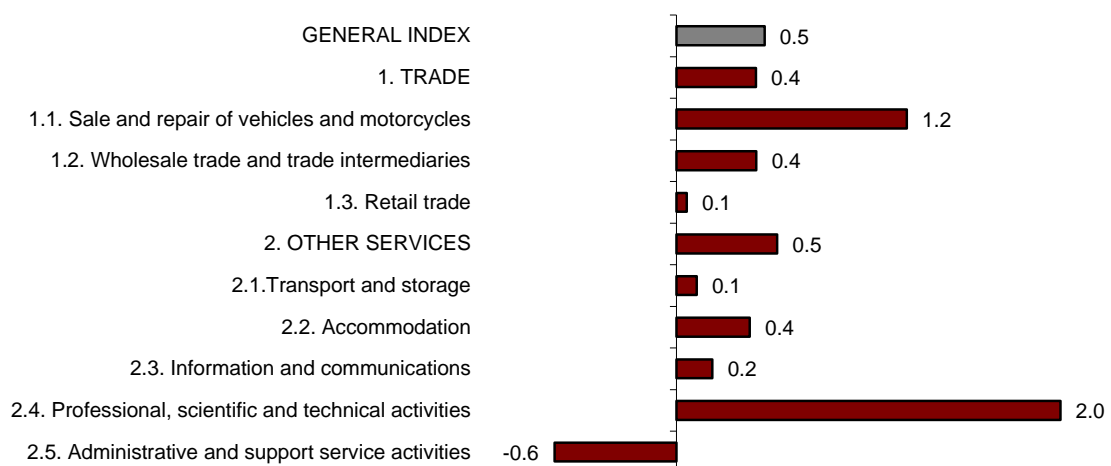
¹ Conforme se recoge en la metodología de este índice de valor, la información se presenta en términos corrientes (nominales), esto es, sin ajustar los efectos en las variaciones de precios en el mismo.

Si se eliminan los efectos estacionales y de calendario, Comercio registra una tasa mensual del 0,4% y Otros Servicios del 0,5%.

Todos los sectores presentan tasas mensuales positivas, excepto *Actividades administrativas y servicios auxiliares* (-0,6%).

Actividades profesionales, científicas y técnicas (2,0%) y *Venta y reparación de vehículos y motocicletas* (1,2%) son los que más suben.

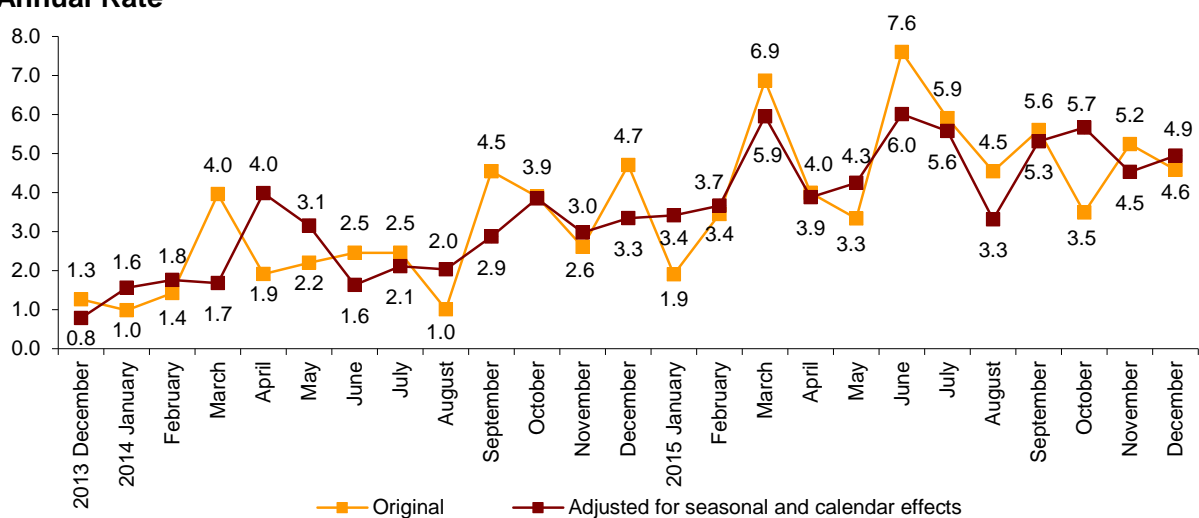
Evolución anual de los índices de cifra de negocios del Sector Servicios de Mercado

El Índice general de la cifra de negocios del Sector Servicios de Mercado corregido de efectos estacionales y de calendario experimenta una variación del 4,9% en diciembre respecto al mismo mes de 2014. Esta tasa es cuatro décimas superior a la registrada en noviembre.

La serie original experimenta una variación anual del 4,6%, lo que supone seis décimas por debajo de la registrada en noviembre.

En el conjunto del año 2015 la cifra de negocios del Sector Servicios de Mercado presentó una variación del 4,7% tanto en la serie corregida como en la original.

Por sectores, si se eliminan los efectos estacionales y de calendario, Comercio sube un 4,9% en diciembre en tasa anual y Otros Servicios un 5,0%.

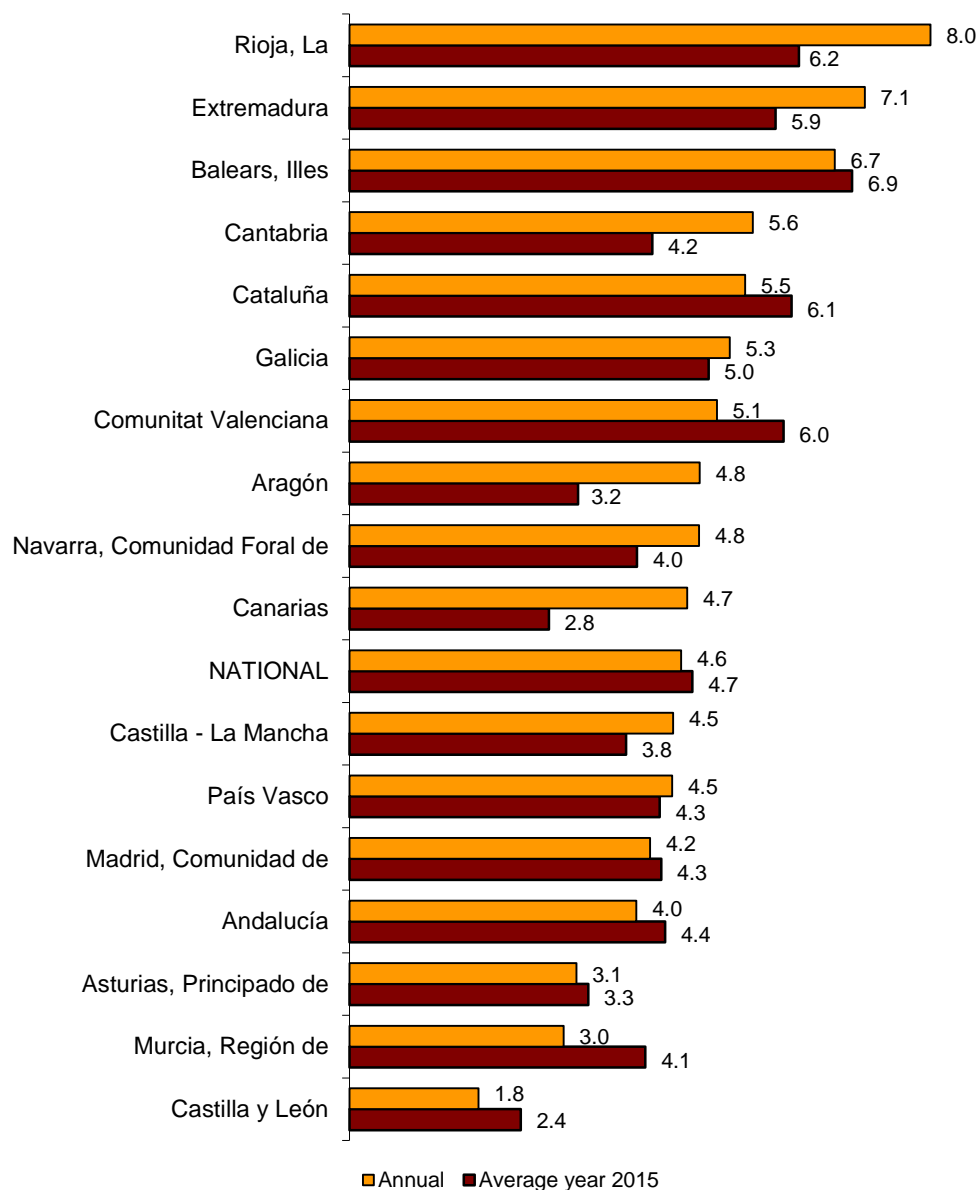
En el conjunto del año 2015, y también con datos de la serie corregida, Comercio aumentó un 4,9% y Otros Servicios un 4,4%.

Todas las comunidades autónomas aumentan su cifra de negocios del Sector Servicios de Mercado en diciembre, La Rioja (8,0%) y Extremadura (7,1%) registran los mayores incrementos.

En el conjunto del año 2015 todas las comunidades presentaron tasas positivas. Illes Balears (6,9%) presentó el mayor incremento.

En el conjunto del año 2015 el empleo creció un 2,0% respecto a 2014.

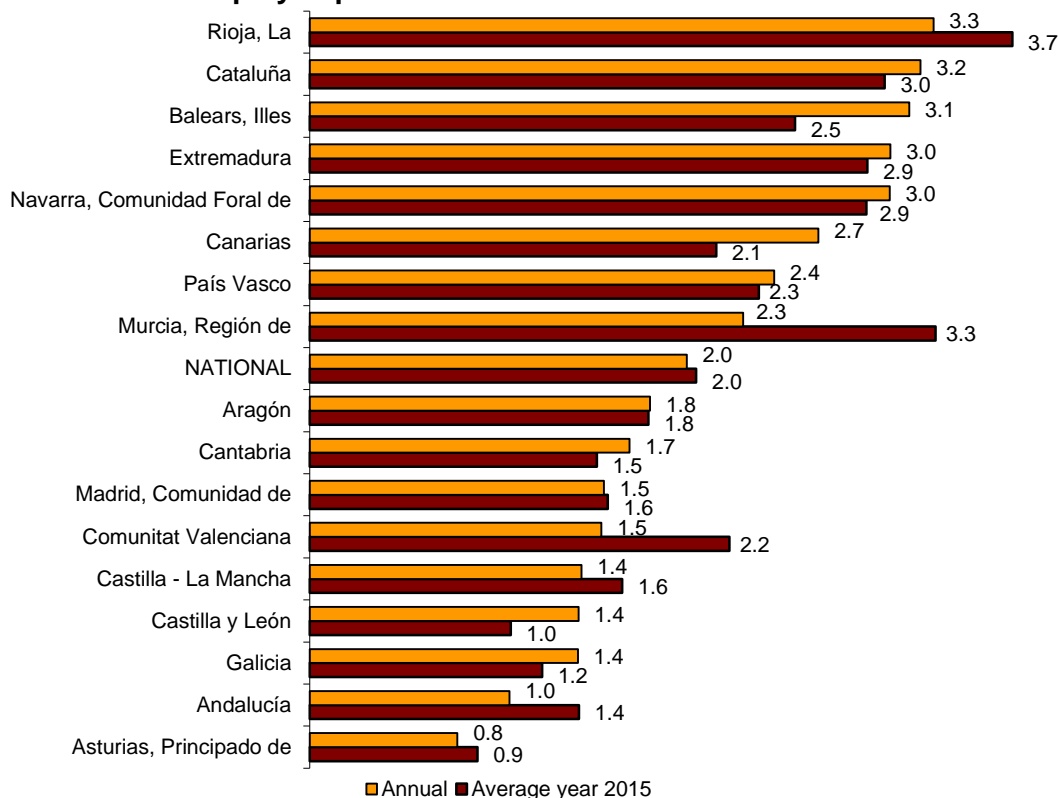
