Harmonised Labour Cost Index (HLCI). Base 2008

First quarter of 2014. Provisional data

After adjusting for calendar and seasonal effects, the quarterly variation of the HLCI is 0.1%


The cost per hour worked increases 0.5% in the first quarter of 2014, as compared to the same period of 2013 in the series adjusted for calendar and seasonal effects, and it decreases 1.6% in the original series

Quarterly variation of the Index

The quarterly variation of the HLCI between the first quarter 2014 and the fourth quarter 2013, after adjusting for calendar and seasonal effects, was 0.1%.

Labour Cost Index


Adjusted for seasonal and calendar effects. Quarterly rate



Annual variation of the Index

The cost per hour worked decreased 1.6% in the first quarter of 2014, as compared with the same period of the previous year, due to the greater number of hours worked, since in 2014 Easter holidays took place during the second quarter of the year, while in 2013 they took place in the first one. After adjusting for calendar and seasonal effects, the annual variation of the cost per hour worked stood at 0.5%.

In turn, the provisional data for the Harmonised Labour Cost Index corresponding to the fourth quarter of 2013 was reviewed, with the general index standing at 113.0 points. After adjusting for calendar and seasonal effects, the variation rate stood at 3.2%.

In the first quarter, the sections of economic activity which registered the greatest growth were Accommodation (1.6%), Water supply, sewerage, waste management and remediation activities (0.9%) and Human health and social work activities (0.3%). In turn, Supply of electrical energy, gas, steam and air conditioning (–6.9%) and Real estate activities (–5.2%) registered the greatest decreases.

After adjusting for seasonal and calendar effects, the economic activities with the greatest annual rates were *Financial and insurance activities* (4.4%) and *Water supply, sewerage, waste management and remediation activities* (3.3%). In turn, the greatest decreases were recorded in *Supply of electrical energy, gas, steam and air conditioning* (–5.9%) and *Real estate activities* (–3.2%).
