December 2014 and Year 2014. Provisional data


The monthly variation of the General Industry Turnover Index¹ stands at –0.7%, after adjusting the seasonal and calendar effects


The annual rate stands at -1.0% in the seasonally and calendar adjusted series and at 2.6% in the original series

In 2014 as a whole, Industrial Turnover increased by 0.5% in the adjusted series and by 0.9% in the original series

Monthly evolution of the Industry Turnover

The monthly variation of the General Industry Turnover Index (ITI) between the months of December and November 2014 was -0.7%, after adjusting for the seasonal and calendar effects. This rate was five tenths lower than that of the previous month.






¹ As explained in the methodology for this value index, the information is presented in current terms (nominal terms), that is, without adjusting the effects in the price variation thereof.

By economic destination of the goods, Non-durable consumer goods (0.9%), Durable consumer goods (0.4%) and Capital goods (0.3%) recorded positive monthly rates. In turn, Energy registered a negative rate of -9.9%.



Annual evolution of the Industrial Turnover indices

The General Industrial Turnover Index (ITI), after adjusting for seasonal and calendar effects, registered a variation of -1.0% in December, as compared to the same month of the previous year. This rate was nearly six tenths lower than that registered in November 2014.

The original series of the ITI registered an annual variation of 2.6%, that is, three points higher than that registered in November 2014.



In 2014 as a whole, the General Industrial Turnover Index (ITI), after adjusting for seasonal and calendar effects, registered a variation of 0.5%, as compared to the year 2013. The rate was 0.9% in the original series.

By economic destination of the goods, four out of five sectors analysed registered positive annual rates, after adjusting for seasonal and calendar effects. Among them, worth noting was the increase of Capital goods (4.3%). In turn, Energy registered a rate of –23.7%.

In 2014 as a whole, Capital goods (5.2%) and Non-durable consumer goods (0.3%) increased, as compared to the year 2013. In turn, Durable consumer goods and Intermediate goods (both at -0.9%), and Energy (-3.3%) registered negative rates.



Annual evolution of the Industrial Turnover Indices by market. Original series

By geographical destination of sales, in December two out of three of the markets analysed registered increases. Worth noting was the 5.5% increase in the domestic market.

Industrial turnover indices: General and by market Annual rate




Results by Autonomous Community. Annual variation rates of the Industrial Turnover. Original series

As compared to December 2013, turnover increased in 11 Autonomous Communities and decreased in the remaining six. The greatest increase was registered in Aragón (17.7%) and the greatest decrease was registered in Canarias (–19.6%).

In 2014 as a whole, industrial turnover increased in 10 Autonomous Communities. Región de Murcia (20.3%), Comunidad Foral de Navarra (6.1%) and Aragón (5.6%) registered the highest rates.
