
#### Industrial New Orders Received Indices (INORI). Base 2015 February 2018. *Provisional data*


The monthly variation of the General Industrial New Orders Received Index<sup>1</sup> is -1.1% after adjusting for seasonal and calendar effects

The annual rate stands at 3.2% in the series adjusted for seasonal and calendar effects and at 3.1% in the original series

#### Monthly evolution of Industrial New Orders Received

The monthly variation of the Industrial New Orders Received Index between February and January, after adjusting for seasonal and calendar effects, was -1.1%. This rate is two tenths lower than the previous month.






<sup>&</sup>lt;sup>1</sup> As reflected in the methodology of this value index, the information is presented in current terms (nominal terms), this is, without adjusting the effects in the price variation of it.

By economic destination of the goods, *Non-durable consumer goods* (2.8%) and *Intermediate goods* (1.1%) registered positive monthly rates. In turn, *Capital goods* (-8.6%), *Energy* (-4.7%) and *Durable consumer goods* (-0.1%) registered negative rates.



#### **Annual evolution of New Orders Received**

The Industry New Order Received Index (INORI) adjusted for seasonal and calendar effects, registered a variation of 3.2% in February, when compared with the same month of the previous year. This rate is 3.6 points lower than that registered in January.

The original series of the INORI registered an annual variation of 3.1%. This rate is 7.5 points lower than that registered in January.

### **Industry New Orders Received General Index Annual rates**



By economic destination of the goods, the indices adjusted for seasonal and calendar effects showed positive annual rates in four of the five sectors analysed. *Intermediate goods* (8.7%) registered the greatest increase.

#### Annual evolution of New Orders Received by market. Original series

By geographical destination of sales, in February, two of the three markets analysed showed positive annual rates. The euro area of the foreign market presented the highest increase (7.7%) and the non-euro area of the foreign market registered the only decrease (-2.5%).

#### Results by Autonomous Communities. Annual variation rate of the Industrial


#### **New Orders Received. Original series**

New orders received increased in 11 Autonomous Communities as compared to February 2017 and decreased in the other six. The greatest increases were registered in Comunidad de Madrid (13.3%), Extremadura (11.6%) and País Vasco, Cantabria and Aragón (9.6% in all three cases). In turn, the greatest decreases were registered in Andalucía (-9.2%), Illes Balears (-4.3%) and Región de Murcia (-3.6%).
