
La variación mensual del Índice General de Entradas de Pedidos en la Industria¹ es del 0,1% si se eliminan los efectos estacionales y de calendario

La tasa anual se sitúa en el 0,2% en la serie corregida de efectos estacionales y de calendario, y en el 2,9% en la serie original

Evolución mensual de las entradas de pedidos en la Industria

La variación mensual del Índice de Entradas de Pedidos de la Industria entre los meses de agosto y julio, eliminando los efectos estacionales y de calendario, es del 0,1%. Esta tasa es 1,4 puntos inferior a la del mes anterior.


**Índice general de entradas de pedidos de la Industria

¹ Conforme se recoge en la metodología de este índice de valor, la información se presenta en términos corrientes (nominales), esto es, sin ajustar los efectos en las variaciones de precios en el mismo.

Por destino económico de los bienes, *Bienes intermedios* (2,5%), *Energía* (0,9%) y *Bienes de consumo no duradero* (0,2%) presentan tasas mensuales positivas. Por su parte, *Bienes de consumo duradero* (-3,4%) y *Bienes de equipo* (-2,7%) registran tasas negativas.


Evolución anual de las entradas de pedidos

El Índice de Entradas de Pedidos en la Industria corregido de efectos estacionales y de calendario presenta en agosto una variación del 0,2% respecto al mismo mes del año anterior. Esta tasa es 4,3 puntos superior a la de julio.

La serie original del IEP experimenta una variación anual del 2,9%. Esta tasa es 12,8 puntos superior a la de julio.

Por destino económico de los bienes, los índices corregidos de efectos estacionales y de calendario presentan tasas anuales positivas en tres de los cinco sectores. Destaca el aumento de *Bienes de consumo duradero* (11,9%) y el descenso de *Energía* (-14,5%).



Por destino geográfico de las ventas, en agosto se observa que todos los mercados presentan tasas anuales positivas. Destaca el aumento del 12,1% en la zona no euro del mercado exterior.


Índices de entradas de pedidos: General y por mercado Tasa anual



Resultados por comunidades autónomas. Tasas de variación anual de las entradas de pedidos. Serie original

Las entradas de pedidos aumentan respecto a agosto de 2015 en 10 comunidades autónomas y disminuyen en las otras siete. El mayor aumento se produce en Comunidad Foral de Navarra (30,5%) y el mayor descenso en Galicia (-12,1%).
