Statistics on Environmental Protection Activities Year 2017

Industry allocated 0.42% of its turnover to environmental protection, reaching 2,519 million euros

Industry expenditure on environmental protection increased by 1.2% in 2017


Industry expenditure on environmental protection amounted to 2,519 million euros in 2017, with an increase of 1.2% over the previous year. This figure represented 0.42% of the sector's turnover.


Current expenditure on environmental protection increased by 3.7%, while investment decreased by 6.1%.

Results by environmental areas

Press

Considering the type of equipment and facilities, 48.9% of the investment was made in independent equipment and facilities and 51.1% in integrated equipment and facilities.

Investment in independent equipment and facilities decreased by 24.8% compared to the previous year. On the other hand, investment in integrated equipment and facilities increased by 23.2%.



The areas of Protection of air and climate (reduction of atmospheric emissions), Waste water management and Waste management accounted for 62.0%, 15.6% and 5.7% of total investment, respectively.

Results by industrial sector. Total expenditure

The sectors that accounted for the highest expenditure on environmental protection in 2017 were *Food, beverages and tobacco* (23.7% of the total), *Chemical and pharmaceutical industry* (16.3%) and *Manufacture of basic metals* (13.6%).

Total expenditure increased by 1.2% over the previous year. The sector with the greatest positive contribution to expenditure growth was *Manufacture of basic metals* (with a contribution of 1.051 points). In turn, *Electricity, gas, steam and air conditioning supply* had the greatest negative contribution (-2.622 points).

Total expenditure by industrial sectors. Year 2017

Total expenditure on environmental protection represented 0.42% of industry turnover in 2017.

The sectors in which this proportion was highest were *Paper, printing and reproduction of recorded media* (0.80%) and *Chemical and pharmaceutical industry* (0.77%).

On the other hand, *Machinery and equipment* (0.12%) and *Transport equipment* (0.14%) presented the lowest ratio of expenditure over turnover.

Results by industrial sector. Current expenditure and investment

Food, beverages and tobacco, Chemical and pharmaceutical industry and Manufacture of basic metals accounted for more than 60% of current expenditure (28.2%, 17.1% and 15.1%, respectively).

Current expenditure increased by 13.1% in Electricity, gas, steam and air conditioning supply and by 13.0% in Transport equipment. In turn, it fell by 6.0% in the Other manufacturing sector.

Press Release

The activity with the greatest investment in environmental protection in 2017 was *Electricity, gas, steam and air conditioning supply*, with 196.4 million euros, 32.8% of the total.

Also noteworthy were the investments made in *Manufacture of coke and refined petroleum products* (89.7 million euros) and in the *Chemical and pharmaceutical industry* (82.4 million euros).

Results by Autonomous Communities

Industrial establishments in Cataluña made the largest expenditure on environmental protection in 2017, with 22.3% of the national total. It was followed by Andalucía (13.8% of the total) and Comunitat Valenciana (9.6%).

By components, the highest current expenditure was made in Cataluña (463.9 million euros) and the highest investment in Andalucía (103.3 million euros).

Expenditure on environmental protection by Autonomous Community. Year 2017



Methodological note

The main objective of the Statistics on environmental protection activities is to have regular, representative and comparable data on expenditure incurred by companies in order to evaluate national and Community policies in this environmental area.

The Survey on Industry Expenditure on Environmental Protection presents the expenditure on environmental protection, both current and investment expenditure, that the industrial sector carries out in order to avoid, reduce or eliminate the pollution resulting from the development of its activity (emissions of pollutants into the air, noise pollution, treatment of wastewater and solid waste generated, etc.).

The fundamental variable for the survey, investment, is broken down by environmental field for both types of existing equipment, "end-of-pipe" equipment and integrated equipment.
