Annual Services Survey Statistics on Products in the Services Sector Year 2013

Turnover in the Services sector decreases 4.0% in 2013, standing at 402,523 million euros

Telecommunications is the activity sector with the greatest productivity, while *Laundry, hairdressing and other personal services* is the activity sector with the lowest productivity

In 2013, the Services sector invoices 13.3% of its total sales abroad, as compared with 12.9% in the previous year

Turnover for companies in the Services sector¹ reached 402,523 million euros in 2013, that is, a 4.0% decrease as compared with the previous year.

The number of companies in the sector decreased 0.7%, and employed personnel did so by 1.9% as compared with 2012.

Results by group of activity²

Press

Almost one-fourth of invoicing for the Services sector in 2013 corresponded to *Transport and storage*. Turnover for this activity registered a decrease of 3.3%, as compared with the previous year.

Information and communications was the following activity group with the highest weight in the invoicing for the Services sector, with 18.2%. Its invoicing registered a decrease of 4.5%.

Regarding employment, Accommodation activities and Administrative and support service activities employed over 45% of the total occupied persons. Employment in Accommodation activities companies dropped by 1.5% as compared with the previous year, while employment in companies of Administrative and support service activities increased by 0.3%.

Results by activity sector 2

On a more disaggregated level, the activity sectors with the greatest contribution to total turnover in 2013 were Land transport and transport via pipelines (10.6% of the total), Food and beverage services (9.7%) and Storage and activities connected to transport (9.4%).

In turn, the sectors that employed the greatest number of persons were *Food and beverage services* (18.2% of the total), *Services in buildings and gardening activities* (10.4%) and *Land transport and transport via pipelines* (9.5%).



The activity sectors registering the greatest increases in turnover in 2013 as compared with the previous year were *Research and development* (11.0%) and *Office administrative and Other business support activities* (9.9%).

In turn, those recording the greatest drops were *Publishing* (-14.6%) and *Real estate* activities (-11.9%).

Productivity



The average productivity (added value per employed person) for the Services sector in the year 2013 reached 35,363 euros, that is, 0.1% less than that registered in the previous year.

The sectors that registered the greatest productivity were *Telecommunications* (226,194 euros) and *Gambling and betting activities* (102,523 euros).

In turn, the sectors that registered the lowest productivity were *Laundry, hairdressing and other personal services* (13,447 euros) and *Veterinary activities* (15,823 euros).

86.7% of sales of companies in the Services sector in 2013 were carried out within Spain, 7.8% targeted European Union countries (EU), and 5.5% went to the rest of the world.

In 2013, sales outside Spain accounted for 53,603 million euros, that is, 13.3% of the total sales, as compared with the 12.9% of the previous year.

The activity sectors with the highest percentage of sales outside Spain were *Air transport* (with 67.1% of sales) and *Technical services* (30.8%).





The graphs below present the Services activities with the highest percentage of sales outside Spain in 2013, as well as those that experienced the greatest increases in the percentage of exports.






Service sectors with the greatest increase in the percentage participation of sales outside Spain. Year 2013-2012



The Services sector was characterised by a predominance of very small companies. In fact, 95.6% of them had fewer than 10 employed persons in 2013. These companies employed 43.0% of the persons employed in services, but its invoice figures did not reach a third of the total turnover for the sector.

In turn, large companies (with 250 or more employed persons), which represented 0.1% of the total companies in the Services sector, invoiced 34.0% of the total.

This atomised structure was repeated to a greater or lesser extent in the different activity sectors comprising the Services sector, with the exception of the companies in *Air transport, Telecommunications, Radio and television activities, Employment-related activities* and *Security and investigation activities* where large companies, albeit small in number, generated most of turnover (more than 70%).

In five activity sectors, companies with 10 or fewer employed persons generated equal or more than 60% of turnover: *Veterinary activities* (83.5%), *Real estate activities* (75.7%), *Artistic and showbusiness activities* (59.9%), *Food and beverage services* (59.7%) and *Laundry, hairdressing and other personal services* (59.7%).


Turnover distribution (in %), by company size and activity sector. Year 2013



Company size and productivity

In 2013, productivity exceeded 46,000 euros in medium and large companies (50 employed persons or more).

In turn, the lowest productivity (24,060 euros) was registered in companies with fewer than 10 employed persons.






Company size and sales outside Spain


In 2013, medium-sized services companies, with 50 or more employed persons, were most likely to export, with almost 17% of invoicing dedicated to sales abroad.


Sales outside Spain by size of the company. Percentage as compared with the total invoicing of each size. Year 2013





In turn, companies from 10 to 49 employed persons recorded the greatest foreign dynamism, with an increase in the percentage of sales outside Spain of 1.0 points, as compared with the previous year. In turn, medium-size companies (from 50 to 249 employed persons) reduced their percentage of sales outside Spain (–0.6 points).





Investment

The total investment (in tangible and intangible assets) of the Services sector enterprises in 2013 reached 27,934 million euros. Over 50% came from *Real estate activities* and *Transport and storage activities*.


Investment accounted for 6.9% of the total turnover. This percentage varies by activity groups, from 3.3% of the *Professional, scientific and technical activities* to 43.8% of the *Real estate activities*.

24,278 million euros of the total investment corresponded to investments in tangible assets (land and natural assets, hardware, buildings, constructions and alterations of buildings, transport equipment, machinery and tools, and other tangible fixed assets), and 3,656 million euros corresponded to investments in intangible goods (software, administrative concessions, intellectual property and other intangible goods).

In comparison to the turnover of the year 2013, investment in material assets accounted for 6.0% while that in intangible goods reached 0.9%.


Investment in tangible and intangible assets over the total turnover (in %), by activity groups. Year 2013



Regarding activity groups *Transport and Storage* and *Accommodation,* investment efforts grew the larger the companies were. In turn, regarding *Real estate activities* and *Administrative and support service activities,* it decreased.

In the rest of the activity groups, companies from 10 to 49 employed persons were those investing the most as compared to their turnover.

Results by Autonomous Community

The Autonomous Communities with the greatest participation in the turnover for the Services sector in 2013 were Comunidad de Madrid (with 33.3% of the total), Cataluña (19.8%) and Andalucía (9.3%).

In turn, those that carried the lowest weight in the turnover for the sector were La Rioja (0.4%), Extremadura and Cantabria (both with 0.8%).



All Autonomous Communities reduced their invoicing in the Services sector in 2013, except for Illes Balears, whose sales increased by 0.7%.

The Autonomous Communities registering the greatest decreases in their turnover were Galicia (-9.8%), Aragón (-8.2%) and Principado de Asturias (-8.0%).

The following chart shows, for each Autonomous Community, the three activity groups of the Services Sector which produced the greatest turnovers in 2013, and the percentages that these activities represented as compared with the total turnover of the Services Sector.

Transport and storage was the activity which contributed the most to the total turnover in most Autonomous Communities, except for Comunidad de Madrid (where *Information and communications* contributed the most) and Illes Balears and Canarias (where the greatest turnover was registered in *Accommodation*).

Statistics on Products in the Services Sector

These statistics enable ascertaining the breakdown of turnover, according to the services provided, as well as the sectors of the clients to whom said services are provided.

Transport (Groups 49.1 to 49.4 and Divisions 51 and 53 of CNAE-2009)

82.5% of invoicing for *Rail transport* corresponded to passenger transport. 51.6% of said invoicing was for inter-city transport.

In turn, seven out of 10 euros invoiced in *Land transport* and in *Sea transport*, and *Transport by domestic navigable routes* came from freight transport.


Air transport companies obtained 83.4% of its turnover thanks to passenger transport, 4.3% thanks to the freight transport and 12.3% thanks to other activities such as handling and repair of aircrafts.

More than half of the turnover income of postal and couriers activities companies was from the *Non-urgent transport of packages weighing 20 kilos or less*.

Companies devoted to road transport of goods invoiced 35.3% of their turnover to clients related to the transport sector, and 29.2% to industrial enterprises.

Hotels and similar accommodation (Group 55.1 of CNAE-2009, companies with 50 employed persons or more)

Nine out of 10 euros invoiced by hotel companies corresponded to accommodation services (Accommodation and catering). The invoicing of this activity increased 1.8% in 2013.


Total invoicing of *Rooms (accommodation only)* increased by 2.0% and that of *Pension (breakfast, half or full board),* did so by 5.3%. In turn, *Catering (except board)* decreased by 0.3%.

Motion picture and video activities (Division 59 of CNAE-2009)

Motion picture, video, television sound and music publishing activities reached an invoicing of 4,636 million euros in 2013, that is, a 4.5% decrease, as compared with the previous year.

By type of services, *Motion picture, video and television programme production* was the only activity that increased in the annual rate (5.7%), while *Motion picture projection* registered the greatest decrease (–19.8%).

Employment-related activities (Division 78 of CNAE-2009)

Placement agencies and temporary employment agencies reached a turnover of 3,245 million euros in 2013, that is, a 0.3% increase, as compared with the previous year.

The total number of hours invoiced increased by 5.2%. Out of the total hours invoiced, these companies spent over 40% of their working hours on *Industry*.



Travel agencies and tour operators invoiced 16,841 million euros in 2013, 6.7% less than in 2013. 64.0% of this figure corresponded to Travel agencies and tour operators with at least 20 employed persons.

49.6% of the turnover was invoiced to national companies (tour operators, travel agencies and other companies), 26.4% to particulars and 22.7% was invoiced to non national tour operators and agencies.

Cleaning activities (Group 82.1 of CNAE-2009)

Turnover of cleaning activities reached 9,140 million euros in 2013, that is, a 1.6% decrease as compared with the previous year.

By company size, large companies (with 250 or more emplyed persons) generated almost 60% of the invoicing in the sector.

By main customers, large companies provided services mainly to Public Administration Services, with 42.6% of the invoicing of these companies. In turn, companies with less than 20 employed persons provided services mainly to households, representing 42.5% of their turnover.

Methodological note

The **Annual Services Survey** is an annual, structural survey aimed at companies, corporations and individuals whose main activity is described in sections H, I, J, L, M, N, R and in sections 95 and 96 of the S part of CNAE-2009. This includes activities of transport and storage, accommodation, information and communications, real estate activities, professional, scientific and technical activities, administrative and support services activities, artistic, recreational and entertainment activities, and the repair of computers, personal effects and household items and other personal services (with the exception of associative activities, Division 94).

This operation enables ascertaining the structural characteristics of those companies mainly devoted to each of the activities included in the study scope, such as their size, the most relevant accounting data (purchases, expenses, capital transactions), employment structure and investment.

The Annual Services Survey sample includes around 80,000 units, selected from a population of approximately 1,300,000 companies, and allows for obtaining representative results at a detailed level of activity, by Autonomous Community, and by the size of companies, according to the number of persons employed. These data can be completed with the data from the short-term statistics, which are updated although less disaggregated.

In order to reduce the statistical burden on the respondent companies, since 2012 has been implementing the mining of administrative sources for elaborating economic surveys (UFAES project). Thus, 23% of the sample selected for service and trade economic structure surveys is estimated by using administrative data. Thus, the number of companies which are asked to fill in the questionnaires has been reduced in around 18,000 companies.

The **Statistics on Products in the Services Sector** is an annual, structural operation integrated in the above operation, and whose main objective is to provide a detailed breakdown of turnover, according to the services provided and the activity sector of the client. This additional breakdown is applied to activities in transport, hotels, computer and audiovisual services, legal and accountancy services, technical services, advertising and market studies, activities of placement agencies, travel agencies and tour operators, and cleaning activities.

Other variables studied in this survey are the breakdown of the purchase of fuels, the mobile transport fleet, the breakdown of purchases in hotels, travel agencies and tour operators, the hours invoiced in companies in the selection and placement of personnel, etc.
