## Quarterly National Accounts of Spain: main aggregates Fourth quarter of 2023 Preview

## Technical note on sources and methods

## Information Sources

This preview of results is compiled with available information, with most indicators providing results up to the second month of the quarter, to which information from advance data, estimates and other additional sources have been added, in line with the recommendations of Eurostat and other international statistical bodies.

However, as was the case in the preview for previous quarters, the INE has added — in addition to information from its regular informational base — advance results from some of its sources for the month of September, indicator estimates based on administrative data, and other additional sources that complement the usual sources, all that in line with Eurostat recommendations and other international statistical agencies.

Among the additional information incorporated are the advance results (with partial collection of information) for commonly used multi-factor indicators; statistics based on records such as those on foreign trade from the Department of Customs and Special Taxes of the Tax Agency (AEAT).

These sources have complemented those normally used, which provide advance results related to the last month of the quarter (December) or to the entire quarter.


