**Industrial Production Index. Base 2000
May 2007**

**The Industrial Production Index adjusted for calendar effects
increases 2.4% in May as compared to the same month in 2006**

The General Industrial Production Index (IPI) experienced a 2.4% variation in May 2007 in comparison with the same month the previous year. After adjusting for calendar effects, the interannual variation of the IPI was estimated at 2.4%.

By economic destination of the goods, the variation rates with respect to the same month from the previous year were 3.0% for consumer goods (-0.7% for durable consumer goods and 3.7% for non-durable consumer goods), 3.9% for capital goods, 0.9% for intermediate goods and 3.8% for energy.

After adjusting for calendar effects, these interannual rates were estimated at 3.1% for consumer goods (-0.7% for durable consumer goods and 3.7% for non-durable consumer goods), 3.8% for capital goods, 0.9% for intermediate goods and 3.8% for energy.

**The average rate of the IPI adjusted for calendar effects increases 3.8% in the
five first months of 2007**

The average IPI rate stood at 4.3% during the first five months of 2007 in comparison with the same month of 2006. After adjusting for calendar effects, this average rate stood at 3.8%.

The evolution of the average industrial production rate by economic destination of the goods was 4.7% for consumer goods (12.8% for durable consumer goods and 3.3% for non-durable consumer goods), 7.7% for capital goods, 4.1% for intermediate goods and -0.7% for energy.

After adjusting for calendar effects, these average rates for the five first months stood at 4.0% for consumer goods (12.0% for durable consumer goods and 2.7% for non-durable consumer goods), 7.2% for capital goods, 3.5% for intermediate goods and -0.8% for energy.

Activities with the greatest growth in the January-May 2007 period were "Manufacture of electrical machinery and material", 16.6%, and "Manufacture of furniture; manufacturing n.e.c. ", 16.2%.

In contrast, those with the lowest growth were "Extraction of Energy products", -15.0%, and "Tanning and dressing of leather; manufacture of luggage, handbags, saddlery, harness and footwear", -11.9%.
