**Industrial Production Index. Base 2000
June 2007**

**The Industrial Production Index adjusted for calendar effects
increases 2.0% in June as compared to the same month in 2006**

The General Industrial Production Index (IPI) experienced a -0.1% variation in June 2007 in comparison with the same month from the previous year. After adjusting for calendar effects, the interannual variation of the IPI was estimated at 2.0%.

By economic destination of the goods, the variation rates with respect to the same month from the previous year were -0.8% for consumer goods (1.7% for durable consumer goods and -1.3% for non-durable consumer goods), 3.6% for capital goods, -0.7% for intermediate goods and -2.7% for energy.

After adjusting for calendar effects, these interannual rates were estimated at 1.8% for consumer goods (5.4% for durable consumer goods and 1.3% for non-durable consumer goods), 5.7% for capital goods, 1.5% for intermediate goods and -2.0% for energy.

**The average rate of the IPI adjusted for calendar effects increases 3.4% in the
five six months of 2007**

The average IPI rate stood at 3.4% during the first six months of 2007 in comparison with the same period of 2006. After adjusting for calendar effects, this average rate stood at 3.4%.

The evolution of the average industrial production rate by economic destination of the goods was 3.6% for consumer goods (10.6% for durable consumer goods and 2.4% for non-durable consumer goods), 7.0% for capital goods, 3.0% for intermediate goods and -1.0% for energy.

After adjusting for calendar effects, these average rates for the five first months stood at 3.6% for consumer goods (10.7% for durable consumer goods and 2.4% for non-durable consumer goods), 7.0% for capital goods, 3.0% for intermediate goods and -1.0% for energy.

Activities with the greatest growth in the January-June 2007 period were "Manufacture of electrical machinery and material", 14.2%, and "Manufacture of furniture; manufacturing n.e.c. ", 13.7%.

In contrast, those with the lowest growth were "Manufacture of office machines and IT equipment", -13.9%, and "Extraction of Energy products ", -11.3%.
