Industrial Prices Indices. Base 2000 February 2007

The General Index of Industrial Prices increases 0.6% in February with respect to the previous month

The General Index of Industrial Prices recorded in February an increase of 0.6% with respect to the month of January in 2007. The activities that most influenced this variation are those of "Manufacture of food products and beverages" (1.0%), "Manufacture of other non-metallic mineral products" (2.0%) and "Manufacture of fabricated metal products, except machinery" (0.7%). In contrast, amongst the activities registering a reduction with respect to the previous month, the one with greatest repercussion is "Coke and refinement of petroleum" (-0.9%).

Considering the classification by economic destination of the goods, the variation rates with respect to the previous month are 0.8% for consumer goods (0.4% for durable consumer goods and 0.8% for non-durable consumer goods), 0.4% for capital goods, 1.1% for intermediate goods and -0.3% for energy.

The General Index increases 2.5% in interannual rate

The General Index of Industrial prices increases 2.5% in February 2007 with respect to the same month from the previous year. The activities that most influence this variation are those of "Metallurgy" (13.1%) and "Production and distribution of electricity and gas" (5.1%).

By economic destination of the goods, the variation rates with respect to the same month from the previous year are 1.5% for consumer goods (2.6% for durable consumer goods and 1.3% for non-durable consumer goods), 2.8% for capital goods, 6.6% for intermediate goods and -2.5% for energy.
