February 2009

**The General Industrial Price Index remains unchanged in February
as compared with the previous month**

The General Industrial Price Index remained unchanged in February, with respect to the month of January 2009. The activities that registered a decrease on the previous month were *Manufacture of paper and paper products* (–1.5%), *Manufacture of basic metals* (–0.7%) and *Manufacture of rubber and plastic products* (–0.6%). In contrast, among the activities registering an increase with respect to the previous month, those with the greatest effect were *Manufacture of food products* (0.1%) and *Manufacture of basic pharmaceutical products and pharmaceutical preparations* (0.6%).

Considering the classification by economic destination of the goods, the variation rates as compared with the previous month were 0.1% for Consumer goods (0.2% for Durable consumer goods and 0.1% for Non-durable consumer goods), –0.2% for Capital goods, –0.2% for Intermediate goods and 0.1% for Energy.

The interannual rate of industrial prices decreases 1.1%

The General Industrial Price Index registered a 1.1% decrease in February 2009 with respect to the same month the previous year. The activities that most influenced this variation were *Manufacture of coke and refined petroleum products* (–33.1%), *Manufacture of basic metals* (–12.8%) and *Manufacture of food products* (–3.6%).

By economic destination of the goods, the interannual variation rates were 0.4% for Consumer goods (2.4% for Durable consumer goods and 0.1% for Non-durable consumer goods), 1.5% for Capital goods, –3.2% for Intermediate goods and –1.9% for Energy.
