Industrial Prices Indices. Base 2000 March 2007

The General Index of Industrial Prices increases 0.6% in March with respect to the previous month

The General Index of Industrial Prices recorded in March an increase of 0.6% with respect to the month of February in 2007. The activities that most influenced this variation are those of "Manufacture of coke and refined petroleum products" (3.0%), "Manufacture of food products and beverages" (0.6%) and "Manufacture of basic metals" (1.7%). In contrast, amongst the activities registering a reduction with respect to the previous month, the one with greatest repercussion is "Manufacture of radio, television and communications equipment and apparatus" (-0.5%).

Considering the classification by economic destination of the goods, the variation rates with respect to the previous month are 0.3% for consumer goods (0.4% for durable consumer goods and 0.3% for non-durable consumer goods), 0.4% for capital goods, 0.5% for intermediate goods and 1.2% for energy.

The General Index increases 2.8% in interannual rate

The General Index of Industrial prices increases 2.8% in March 2007 with respect to the same month from the previous year. The activities that most influence this variation are those of "Production and distribution of electricity and gas " (5.2%) and "Metallurgy" (12.2%).

By economic destination of the goods, the variation rates with respect to the same month from the previous year are 1.7% for consumer goods (2.9% for durable consumer goods and 1.5% for non-durable consumer goods), 3.3% for capital goods, 6.2% for intermediate goods and -1.6% for energy.
