Industrial Price Indices. Base 2000
April 2007

The General Industrial Price Index increases 0.5% in April with respect to the previous month

The General Industrial Price Index recorded in April an increase of 0.5% with respect to the month of March 2007. The activities that most influenced this variation were the "Manufacture of coke and refined petroleum products" (3.1%), the "Manufacture of basic metals" (2.6%) and the "Manufacture of food products and beverages" (0.7%). In contrast, amongst the activities registering a reduction with respect to the previous month, the one with greatest repercussion is the "Production and distribution of electricity and gas" (-1.0%).

Considering the classification by economic destination of the goods, the variation rates with respect to the previous month are 0.5% for consumer goods (0.3% for durable consumer goods and 0.5% for non-durable consumer goods), 0.2% for capital goods, 0.6% for intermediate goods and 0.7% for energy.

The General Industrial Price Index increased 2.7% in April 2007 with respect to the same month from the previous year. The activities that most influenced this variation were the "Manufacture of basic metals" (11.4%) and the "Manufacture of food products and beverages" (2.9%).

By economic destination of the goods, the variation rates with respect to the same month from the previous year are 2.2% for consumer goods (2.9% for durable consumer goods and 2.1% for non-durable consumer goods), 3.2% for capital goods, 6.4% for intermediate goods and -2.6% for energy.
