Industrial Price Indices. Base 2000
May 2007

The General Industrial Price Index increases 0.5% in May with respect to the previous month

The General Industrial Price Index recorded in May an increase of 0.5% with respect to the month of April 2007. The activities that most influenced this variation were the "Manufacture of coke and refined petroleum products" (2.5%), the "Manufacture of basic metals" (1.5%) and the "Manufacture of fabricated metal products, except machinery" (0.6%). In contrast, amongst the activities registering a reduction with respect to the previous month, the one with greatest repercussion was the "Publishing, printing and reproduction of recorded media" (-0.2%).

Considering the classification by economic destination of the goods, the variation rates with respect to the previous month were 0.1% for consumer goods (0.2% for durable consumer goods and 0.1% for non-durable consumer goods), 0.4% for capital goods, 0.6% for intermediate goods and 1.0% for energy.

The interannual rate of the industrial prices increases 2.4%

The General Industrial Price Index increased 2.4% in May 2007 with respect to the same month from the previous year. The activities that most influenced this variation were the "Manufacture of food products and beverages" (2.7%) and the "Manufacture of basic metals" (8.5%).

By economic destination of the goods, the variation rates with respect to the same month from the previous year were 2.0% for consumer goods (2.6% for durable consumer goods and 1.9% for non-durable consumer goods), 3.4% for capital goods, 6.0% for intermediate goods and -2.8% for energy.
