May 2009****The General Industrial Price Index increases 0.1% in May as compared to the previous month**

In May, the General Industrial Price Index registered a 0.1% increase, as compared with the month of April 2009. The activities that registered an increase on the previous month were *Manufacture of coke and refined petroleum products* (4.6%) and *Manufacture of rubber and plastic products* (0.5%). Conversely, among the activities that registered a decrease with respect to the previous month, those with the greatest effect were *Manufacture of basic metals* (–1.0%) and *Manufacture of paper and paper products* (–1.3%).

Considering the classification by economic destination of the goods, the variation rates as compared with the previous month were –0.3% for Consumer goods (–0.5% for Durable consumer goods and –0.3% for Non-durable consumer goods), –0.3% for Intermediate goods and 1.2% for Energy. Capital goods did not experience any variation.

The interannual rate of industrial prices decreases 4.4%

The General Industrial Price Index registered a 4.4% decrease in May 2009, as compared with the same month the previous year. The activities that most influenced this variation were *Manufacture of coke and refined petroleum products* (–41.5%), *Manufacture of basic metals* (–23.7%) and *Manufacture of food products* (–5.8%).

By economic destination of the goods, the interannual variation rates were –1.2% for Consumer goods (0.9% for Durable consumer goods and –1.5% for Non-durable consumer goods), 1.1% for Capital goods, –6.3% for Intermediate goods and –9.7% for Energy.
