Industrial Price Indices. Base 2000
June 2007

The General Industrial Price Index increases 0.2% in June with respect to the previous month

In June, the General Industrial Price Index registered a 0.2% increase with respect to the month of May 2007. The activities that most influenced this variation were *Manufacture of coke and refined petroleum products* (1.3%), *Food and beverage products industry* (0.2%) and *Paper industry* (1.2%). In contrast, among the activities that recorded a decrease with respect to the previous month, the activity with the greatest effect was *Metallurgy* (-0.4%).

Considering the classification by economic destination of the goods, the variation rates with respect to the previous month were 0.1% for consumer goods (0.2% for durable consumer goods and no variation for non-durable consumer goods), 0.2% for intermediate goods and 0.6% for energy. Capital goods did not experience any variation.

The interannual rate of the General Index increases 2.6%

The General Industrial Price Index registered an increase of 2.6% in June 2007 with respect to the same month from the previous year. The activities that most influenced this variation were *Food and beverage products industry* (2.4%) and *Production and distribution of electricity and gas* (3.8%).

By economic destination of the goods, the variation rates with respect to the same month from the previous year were 1.8% for consumer goods (2.9% for durable consumer goods and 1.6% for non-durable consumer goods), 3.1% for capital goods, 5.8% for intermediate goods and -1.4% for energy.
