Industrial Price Indices. Base 2005
June 2009

The General Industrial Price Index increases 0.5% in June as compared to the previous month

In June, the General Industrial Price Index registered a 0.5% increase, as compared with the month of May 2009. Of the activities that registered an increase on the previous month, those with the greatest effect were *Manufacture of coke and refined petroleum products* (10.2%) and *Electricity and gas* (0.3%). Conversely, among the activities that registered a decrease with respect to the previous month, that with the greatest effect was *Manufacture of basic metals* (–0.9%).

Considering the classification by economic destination of the goods, the variation rates as compared with the previous month were –0.1% for Capital goods, –0.2% for Intermediate goods and 3.1% for Energy. Consumer goods did not experience any variation.

The interannual rate of industrial prices decreases 5.0%

The General Industrial Price Index registered a 5.0% decrease in June 2009, as compared with the same month the previous year. The activities that most influenced this variation were *Manufacture of coke and refined petroleum products* (–40.5%), *Manufacture of basic metals* (–26.3%) and *Manufacture of food products* (–5.7%).

By economic destination of the goods, the interannual variation rates were –1.3% for Consumer goods (0.9% for Durable consumer goods and –1.7% for Non-durable consumer goods), 0.9% for Capital goods, –6.9% for Intermediate goods and –10.2% for Energy.
