

Industrial Price Indices. Base 2000
August 2007

The General Industrial Price Index increases 0.2% in August with respect to the previous month

In August, the General Industrial Price Index registered a 0.2% increase with respect to the month of July 2007. The activities that most influenced this variation were *Food and beverage products industry* (1.0%) and *Manufacture of chemicals and chemical products* (0.3%). In contrast, among the activities that recorded a decrease with respect to the previous month, the activity with the greatest effect was *Manufacture of coke and refined petroleum products* (-0.9%).

Considering the classification by economic destination of the goods, the variation rates with respect to the previous month were 0.3% for consumer goods (0.5% for non-durable consumer goods and no variation for durable consumer goods), 0.1% for capital goods, 0.2% for intermediate goods and -0.4% for energy.

The interannual rate of the General Index increases 2.3%

The General Industrial Price Index registered an increase of 2.3% in August 2007 with respect to the same month from the previous year. The activities that most influenced this variation were *Food and beverage products industry* (3.7%) and *Manufacture of metal products, except machinery and equipment* (5.8%).

By economic destination of the goods, the variation rates with respect to the same month from the previous year were 2.3% for consumer goods (2.8% for durable consumer goods and 2.3% for non-durable consumer goods), 3.1% for capital goods, 5.4% for intermediate goods and -2.8% for energy.
