Industrial Price Indices. Base 2000 October 2007

The General Industrial Price Index increases 0.9% in October as compared with the previous month

In October, the General Industrial Price Index registered a 0.9% increase with respect to the month of September 2007. The activities that most influenced this variation were *Food and beverage products industry* (2.2%) and *Manufacture of coke and refined petroleum products* (3.8%). In contrast, among the activities that recorded a decrease with respect to the previous month, the activity with the greatest repercussion was *Metallurgy* (-0.9%).

Considering the classification by economic destination of the goods, the variation rates as compared with the previous month were 0.9% for consumer goods (0.3% for durable consumer goods and 1.1% for non-durable consumer goods), 0.1% for capital goods, 0.5% for intermediate goods and 2.4% for energy.

The interannual rate of the General Index increases 4.7%

The General Industrial Price Index registered an increase of 4.7% in October 2007 with respect to the previous year. The activities that most influenced this variation were *Food and beverage products industry* (8.3%) and *Manufacture of coke and refined petroleum products* (8.0%).

By economic destination of the goods, the variation rates as compared with the previous year were 4.2% for consumer goods (3.1% for durable consumer goods and 4.4% for non-durable consumer goods), 3.2% for capital goods, 5.3% for intermediate goods and 6.1% for energy.
