**The General Industrial Price Index remains unchanged in October
as compared with the previous month**

**The interannual rate reaches -4.2%, as compared with -5.4% in
September 2009**

Monthly variation rates

The General Industrial Price Index remained unchanged in October, as compared with the month of September 2009. Of the activities that registered a decrease in the previous month, those with the greatest effect were *Manufacture of food products* (-0.9%) and *Manufacture of chemicals and chemical products* (-0.4%). Conversely, among the activities that registered an increase as compared with the previous month, that with the greatest effect were *Manufacture of coke and refined petroleum products* (2.8%) and *Manufacture of basic metals* (0.6%).

Considering the classification by **economic destination of the goods**, the variation rates as compared with the previous month were -0.3% for *Consumer goods* (-0.2% for *Durable consumer goods* and -0.4% for *Non-durable consumer goods*), -0.1% for *Capital goods*, -0.2% for *Intermediate goods* and 0.8% for *Energy*.

Interannual variation rates

The Industrial Price Index registered a 4.2% decrease in October 2009, as compared with the same month the previous year. The activities that most influenced this variation were *Manufacture of coke and refined petroleum products* (-24.1%), *Manufacture of basic metals* (-20.3%) and *Manufacture of food products* (-4.2%).

By **economic destination of the goods**, the interannual variation rates were -0.6% for *Consumer goods* (0.1% for *Durable consumer goods* and -0.8% for *Non-durable consumer goods*), 0.2% for *Capital goods*, -6.3% for *Intermediate goods* and -8.2% for *Energy*.
