

**Industrial Price Index. Base 2015**  
October 2022. Provisional data

**The annual variation of the Industrial Price Index fell almost nine and a half points, to 26.1%**

**The monthly rate of industrial prices was -1.4%**

#### **Annual evolution of industrial prices**

The annual rate of the general Industrial Price Index (IPRI) was 26.1% in the month of October, nearly and a half points above that registered in September.


Among the industrial sectors with a negative influence on the evolution of the annual rate of the General IPRI, and by the economic destination of the goods, worth noting were:

- **Energy**, whose annual rate of 54.1% was more than 30 points below that of the previous month. This was a consequence of the decreases in the prices of the *Production, transport and distribution of electric power* and, to a lesser extent, of the *Manufacture of gas; distribution of gaseous fuels through mains*, which increased in the same month of the previous year.
- **Intermediate goods**, whose variation decreased by more than two and a half points to stand at 15.9%. This evolution is caused by the decrease in the prices of *Manufacture of basic chemicals, fertilisers and nitrogen compounds, plastics and synthetic rubber in primary forms* and of *Manufacture of basic precious and other non-ferrous metals*, which rose in October of the previous year.

On the other hand, among the industrial sectors with a positive influence, worth noting were:

- **Non-durable consumer goods**, with a variation of 14.2%. This was one point above that of September, due to the fact that the prices of the *Manufacture of vegetable and animal oils and fats* increased more this month than they did in October 2021.

## Contribution of industrial sectors to the annual rate of the IPRI




### Annual rate difference IPRI -9.5

The annual variation rate of the general index excluding Energy decreased by eight points, to 13.2%, standing nearly 13 and a half points below that of the general IPRI.

## Monthly evolution of industrial prices

In October, the monthly variation rate of the overall IPRI was -1.4%.

By economic destination of the goods, the industrial sectors that presented a negative monthly effect on the index were:

- **Energy**, which registered a variation rate of -4.7% and a contribution of -1.743, due to the decreases in the prices of *Electric power generation, transmission and distribution* and *Manufacture of gas; distribution of gaseous fuels through mains*.

While in a positive direction, the rise in *oil refinery* prices should also be noted.


- **Intermediate goods** had a rate of -0.1%. This was due to decreases in the prices of *Manufacture of basic iron and steel and of ferro-alloys* and *Manufacture of basic chemicals, fertilisers and nitrogen compounds, plastics and synthetic rubber in primary forms*. The contribution of this sector to IPRI was -0.035.

On the other hand, worth noting amongst the industrial sectors with a positive monthly effect were:

- **Non-durable consumer goods**, with a variation of 1.3% and a contribution of 0.315. This was primarily caused by the increase in the prices of *Manufacture of vegetable and animal oils and fats*.

## Results by Autonomous Communities. Annual variation rates


In October, the annual rate of the IPRI fell in all autonomous communities.

The largest decreases were registered in Illes Balears, Canarias and Principado de Asturias, whose rates decreased by 27.9, 26.5 and 25.8 points, respectively.

On the other hand, La Rioja, Comunitat Valenciana and Cataluña were the communities in which the rate rose, with increases of 4.2, 4.4 and 5.2 points, respectively.

## **Data Review and Update**

## **Methodological note**

The Industrial Price Index (IPRI) is a short-term indicator that measures the monthly evolution of the prices of industrial products manufactured and sold in the domestic market, in the first step of their commercialisation, that is to say, at ex-factory prices, excluding transport and commercialisation costs and invoiced VAT.

**Type of survey:** monthly continuous survey.

Base year: 2015.

**Reference period of the weightings:** the year preceding the current year

**Population scope:** industrial workplaces

**Sample size:** 9,000 industrial establishments and 1,500 items.

**Number of observations:** approximately 28,000 monthly prices.

**General calculation method:** Laspeyres' Chain Index.

**Collection method:** internet (IRIA system), e-mail, fax, telephone or postal mail.
