

Industrial Price Indices. Base 2000
November 2007

The General Industrial Price Index increases 0.6% in November as compared to the previous month

In November, the General Industrial Price Index registered a 0.6% increase with respect to the month of October 2007. The activities that most influenced this variation were *Manufacture of coke and refined petroleum products* (6.1%) and *Food and beverage products industry* (0.7%). In contrast, among the activities that recorded a decrease with respect to the previous month, the activity with the greatest repercussion was *Metallurgy* (-1.8%).

Considering the classification by economic destination of the goods, the variation rates as compared with the previous month were 0.2% for consumer goods (0.1% for durable consumer goods and 0.2% for non-durable consumer goods), 0.1% for capital goods, 0.1% for intermediate goods and 2.7% for energy.

The interannual rate of the General Index increases 5.4%

The General Industrial Price Index registered an increase of 5.4% in November 2007 with respect to the previous year. The activities that most influenced this variation were *Food and beverage products industry* (8.9%) and *Manufacture of coke and refined petroleum products* (16.8%).

By economic destination of the goods, the variation rates as compared with the previous year were 4.4% for consumer goods (3.1% for durable consumer goods and 4.6% for non-durable consumer goods), 3.1% for capital goods, 5.2% for intermediate goods and 9.8% for energy.
