Mercantile Companies Statistics (MC) January 2022. Provisional data

In January, 8,195 mercantile companies were created, 4.9% more than in the same month of 2021

The number of companies dissolved was 3,715, with an annual increase of 23.2%

In January, 8,195 mercantile companies were created, 4.9% more than in the same month of 2021. The share capital for their constitution exceeded 503 million Euros, with an annual decrease of 19.8% The average subscribed capital (61,402 euros) decreased by 23.6%.

On the other hand, in January, a total of 3,182 mercantile companies increased their capital, 4.7% more than for the same month of 2021. The capital subscribed in the increases registered a decrease of 23.3% and exceeded 2,049 million euros. The average capital subscribed in these transactions (643,959 euros) decreased 26.8% in the annual rate.

The number of mercantile companies dissolved in January was 3,715, indicating 23.2% more than in the same month of 2021. Of these, 85.5% did so voluntarily, 8.5% due to mergers and the remaining 6.0% for other reasons.



In order to contribute to the analysis and interpretation of the data, the following chart shows the variation of the number of mercantile companies created and dissolved between December and January in the last five years. In 2022, the monthly variation in the number of companies created was -2.4% and 21.8% in the number of companies dissolved.

Performance of the monthly rate of mercantile companies created and dissolved January variation is compared with December of the same year. Percentage




Results by main economic activity

Of the mercantile companies created in January, 19.6% corresponded to *Trade* and 16.2% to *Real estate, financial and insurance companies.* As for dissolved companies, 20.0% corresponded to *Trade* and 17.6% to *Construction*.

Mercantile companies created by main economic activity


January 2022. Percentage



The economic activity with the largest subscribed capital of mercantile companies created was *Real estate, financial and insurance*, with 339.55 million euros. In turn, *Information and communications* presented the lowest subscribed capital, with 2.88 million.

Capital subscribed of mercantile companies created by main economic activity



In regard to the average subscribed capital of the mercantile companies created, *Real Estate, financial and insurance* registered the highest, with 255,764 euros per company. In turn, *Information and communications* registered the lowest average subscribed capital, with 7,977 euros.

The Autonomous Communities with the greatest number of mercantile companies created in January were Comunidad de Madrid (1,692), Cataluña (1,553), and Andalucía (1,482).

Conversely, the Autonomous Communities where less mercantile companies were created were La Rioja (28), Cantabria (61) and Comunidad Foral de Navarra (76).

In regard to dissolved mercantile companies, the Autonomous Communities that registered the highest number of dissolutions were Comunidad de Madrid (1,068), Andalucía (568) and Comunitat Valenciana (377).


In turn, those with the lowest number of dissolutions were Comunidad Foral de Navarra (16), Región de Murcia (25) and La Rioja (31).


Aragón (36.1%), Galicia (20.6%) and Comunitat Valenciana (18.8%) had the highest annual rates in the number of mercantile companies created. In turn, Principado de Asturias (-27.0%), Región de Mucia (-21.6%) and Cataluña (-6.0%) registered the largest decreases.

Regarding the mercantile companies dissolved, the highest rates were recorded in Comunidad Foral de Navarra (166.7%), Cataluña (36.9%) and Andalucia (35.2%). On the other hand, the only communities with a negative annual variation were Castilla - La Mancha (-21.9%) and Principado de Asturias (-14.1%).

Revision and updating of data

Data for 2022 is provisional and will be reviewed when the data for the same period of the next year is published. That is, when the data for January 2023 are published, the final data for the same month in 2022 will be disseminated.

Methodological note

The Mercantile Companies Statistics was created by Order of 30 December 1938. Its objective is to measure the demographics of companies, providing monthly information, at provincial and Autonomous Community level, on the companies created, dissolved and those in which there have been changes in capital.

The source of information is the Central Mercantile Registry, which collects all provincial information on the registration of companies and entrepreneurs, as well as mercantile acts determined by law.

Type of survey: monthly continuous survey.

Population scope: set of companies registered in the Central Mercantile Register.

Geographical scope: the entire national territory, by Autonomous Communities and provinces

Reference period of the results: the calendar month.

Reference period of the information: the calendar month

Collection method: administrative records.
