Mercantile Companies Statistics (MC)

February 2022. Provisional data

In February, 9,237 mercantile companies were created, 5.1% more than in the same month of 2021

The number of companies dissolved was 2,430, with an annual decrease of 2.9%

In February, 9,237 mercantile companies were created, 5.1% more than in the same month of 2021. The subscribed capital for their constitution exceeded 709 million euros, with an annual increase of 18.6%. The average subscribed capital (76,802 euros) increased by 12.8%.

On the other hand, 2,804 mercantile companies increased their capital in February, 5.0% less than in the same month of 2021. The capital subscribed in the increases grew 1.2% and exceeded 2,102 million euros. The average capital subscribed in these transactions (749,736 euros) increased 6.5% in the annual rate.

The number of mercantile companies dissolved in February was 2,430, indicating 2.9% less than in the same month of 2021. Of these, 82.0% did so voluntarily, 8.5% due to mergers and the remaining 9.5% for other reasons.



Evolution of the monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation of the number of mercantile companies created and dissolved between January and February in the last five years. In 2022, the monthly variation in the number of companies created was 12.7%, and -34.6% in the number of companies dissolved.

Performance of the monthly rate of mercantile companies created and dissolved


February variation is compared with January of the same year. Percentage




Results by main economic activity

Of the mercantile companies created in February, 19.1% corresponded to *Trade* and 16.7% to *Real estate, financial and insurance companies*. As for dissolved companies, 22.1% corresponded to *Trade* and 17.5% to *Construction*.

Mercantile companies created by main economic activity




Mercantile companies dissolved by main economic activity



The economic activity with the largest subscribed capital of mercantile companies created was *Real estate, financial and insurance*, with 535.75 million euros. In turn, *Information and communications* presented the lowest subscribed capital, with 3.17 million.


Capital subscribed of mercantile companies created by main economic activity February 2022. Thousands of euros



In regard to the average subscribed capital of the mercantile companies created, *Real Estate, financial and insurance* registered the highest, with 347,311 euros per company. In turn, *Information and communications* registered the lowest average, with 6,726 euros.

Results by Autonomous Community

The Autonomous Communities with the greatest number of mercantile companies created in February were Comunidad de Madrid (2,262), Cataluña (1,628), and Andalucía (1,586).

In turn, those with the lowest number of mercantile companies created were La Rioja (42), Cantabria (49) and Comunidad Foral de Navarra (69).

Regarding dissolved mercantile companies, the ones that registered the highest number were Comunidad de Madrid (679), Andalucía (428) and Cataluña (223).


In turn, those registering the lowest number of dissolutions were La Rioja (12), Comunidad Foral de Navarra (24) and Principado de Asturias (27).


Extremadura (36.5%), País Vasco (19.0%) and Castilla y León (18.2%) registered the highest annual increases in the number of mercantile companies created. In turn, Cantabria (-42.4%), Comunidad Foral de Navarra (-22.5%) and Región de Murcia (-10.8%) registered the greatest decreases.

Regarding the mercantile companies dissolved, the highest rates were recorded in Comunidad Foral de Navarra (380.0%), Extremadura (82.6%) and Canarias (33.3%). Conversely, the greatest decreases took place in La Rioja (-64.7%), Principado de Asturias (-48.1%) and Galicia (-24.2%).

Revision and updating of data

Data for 2022 is provisional and will be reviewed when the data for the same period of the next year is published. In other words, when the data for February 2023 are published, the final data for the same month in 2022 will be disseminated.

Methodological note

The Mercantile Companies Statistics was created by Order of 30 December 1938. Its objective is to measure the demographics of companies, providing monthly information, at provincial and Autonomous Community level, on the companies created, dissolved and those in which there have been changes in capital.

The source of information is the Central Mercantile Registry, which collects all provincial information on the registration of companies and entrepreneurs, as well as mercantile acts determined by law.

Type of survey: monthly continuous survey.

Population scope: set of companies registered in the Central Mercantile Register.

Geographical scope: the entire national territory, by Autonomous Communities and provinces

Reference period of the results: the calendar month.

Reference period of the information: the calendar month

Collection method: administrative records.
