Mercantile Companies Statistics (MC) March 2021. Provisional data

In March, 10,968 mercantile companies were created, 61.8% more than in the same month of 2020.

The number of companies dissolved was 2,121, with an annual increase of 44.3%

In March, 10,968 mercantile companies were created, 61.8% more than in the same month of 2020. The subscribed capital for their constitution exceeded 420 million euros, with an annual increase of 2.1%. The average subscribed capital (38,305 euros) decreased by 36.9%.

On the other hand, in March, a total of 2,927 mercantile companies increased their capital, 38.9% more than in the same month of 2020. The capital subscribed in the increases grew by $187.2\%^1$ and exceeded 4,450 million euros. The average subscribed capital in these transactions (1,520,342 euros) increased by 106.8% in the annual rate.

The number of mercantile companies dissolved in March was 2,121, indicating 44.3% more than in the same month of 2020. Of these, 76.3% did so voluntarily, 8.1% due to mergers and the remaining 15.6% for other reasons.

Evolution of the monthly rate



In order to contribute to the analysis and interpretation of the data, the following chart shows the variation of the number of mercantile companies created and dissolved between February and March in the last five years. In 2021, the monthly variation in the number of companies created was 24.8%, and -15.2% in the number of companies dissolved.

Performance of the monthly rate of mercantile companies created and dissolved


November variation is compared with October of the same year. Percentage



Results by main economic activity

Of the mercantile companies created in March, 21.6% corresponded to *Trade* and 14.8% to *Real estate, financial and insurance companies.* Regarding the dissolved companies, 19.2% corresponded to *Trade* and 16.9% to *Construction*.


Mercantile companies created by main economic activity



Mercantile companies dissolved by main economic activity




The economic activity with the largest subscribed capital of mercantile companies created was *Real estate, financial and insurance*, with 225.90 million euros. In turn, *Information and communications* presented the lowest subscribed capital, with 4.08 million.

In regard to the average subscribed capital of the mercantile companies created, *Real Estate, financial and insurance* registered the highest, with 139,166 euros per company. In turn, *Information and communications* registered the lowest average subscribed capital, with 7,584 euros.

The Autonomous Community with the greatest number of mercantile companies created in March were Comunidad de Madrid (2,511), Andalucía (2,110), and Cataluña (2,031).

In turn, those with the lowest number of mercantile companies created were La Rioja (55), Cantabria (76) and Comunidad Foral de Navarra (84).


Regarding dissolved mercantile companies, the ones that registered the highest number were Comunidad de Madrid (613), Andalucía (357) and Cataluña (187).

In turn, those with the lowest number of dissolved companies were Comunidad Foral de Navarra (eight), La Rioja (16) and Cantabria (23).

Mercantile companies created and dissolved by Autonomous Community March 2021




All the communities showed positive annual rates in the number of mercantile companies created. Castilla–La Mancha (115.2%), Región de Murcia (89.1%) and Andalucia (77.3%) registered the greatest increases. In turn, Canarias (22.3%), Principado de Asturias (41.2%) and Comunidad de Madrid (45.3%) registered the smallest increases.

Regarding the mercantile companies dissolved, the highest rates were recorded in Comunidad Foral de Navarra (700.0%), Región de Murcia (190.9%) and La Rioja (100.0%). In turn, the only Autonomous Communities with a negative annual variation rate were Principado de Asturias (-8.0%) and Canarias (-4.2%).





Revision and updating of data

2021 data is provisional and will be revised when the data for the same period of the following year is published. In other words, when the data for March 2022 are published, the final data for the same month of 2021 will be disseminated.

Methodological note

The Mercantile Companies Statistics (MCS) was created by Order of 30 September 1938. Its objective is to measure the demographics of companies, providing monthly information, at provincial and Autonomous Community level, on the companies created, dissolved and those in which there have been changes in capital.

The source of information is the Central Mercantile Registry, which collects all provincial information on the registration of companies and entrepreneurs, as well as mercantile acts determined by law.

Type of survey: monthly continuous survey.

Population scope: set of companies registered in the Central Mercantile Register.

Geographical scope: the entire national territory, by Autonomous Communities and provinces.

Reference period of the results: the calendar month.

Reference period of the information: the calendar month.

Collection method: administrative records.
