## Mercantile Companies Statistics (MC) March 2022. Provisional data

# In March, 11,071 mercantile companies were created, 0.6% more than in the same month of 2021.

# The number of companies dissolved was 2,557, with an annual increase of 19.9%

In March, 11,071 mercantile companies were created, 0.6% more than in the same month of 2021. The subscribed capital for their constitution exceeded 391 million euros, with an annual decrease of 7.1%. The average subscribed capital (35,369 euros) decreased by 7.6%.

On the other hand, 2,865 mercantile companies increased their capital in March, 2.6% less than in the same month of 2021. The capital subscribed in the increases registered a decrease of 50.2% and exceeded 2,218 million euros. The average capital subscribed in these transactions (774,218 euros) decreased 48.9% in the annual rate.

The number of mercantile companies dissolved in March was 2,557, indicating 19.9% more than in the same month of 2021. Of these, 69.3% did so voluntarily, 21.3% due to mergers and the remaining 9.4% for other reasons.


#### Evolution of the monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation of the number of mercantile companies created and dissolved between February and March in the last five years. In 2022, the monthly variation in the number of companies created was 19.9%, and 5.2% in the number of companies dissolved.

#### **Performance of the monthly rate of mercantile companies created and dissolved** November variation is compared with October of the same year. Percentage




#### Results by main economic activity

Of the mercantile companies created in March, 19.6% corresponded to *Trade* and 16.2% to *Real estate, financial and insurance companies.* Regarding dissolved companies, 24.3% corresponded to *Industry and energy* and 17.5% to *Trade*.

March 2022. Percentage





The economic activity with the largest subscribed capital of mercantile companies created was *Real estate, financial and insurance*, with 221.75 million euros. In turn, *Administrative and support service activities* registered the lowest capital, with 4.86 million.

## Subscribed capital of mercantile companies created by main economic activity



In regard to the average subscribed capital of the mercantile companies created, *Real Estate, financial and insurance* registered the highest, with 123,638 euros per company. In turn, *Administrative and support service activities* registered the lowest, with 9,341 euros.

### **Results by Autonomous Community**

The Autonomous Communities with the greatest number of mercantile companies created in March were Comunidad de Madrid (2,484), Cataluña (2,191), and Andalucía (1,921).

In turn, those in which the fewest mercantile companies have been created were La Rioja (45), Comunidad Foral de Navarra (72), and Cantabria (83).

The Autonomous Communities with the highest number of dissolved mercantile companies were Comunidad de Madrid (1,030), Andalucía (376) and Cataluña (219).

In turn, those with the lowest number of dissolutions were Comunidad Foral de Navarra (six), La Rioja (13) and Extremadura (23).



Principado de Asturias (56,3%), Illes Balears (30,6%) and Canarias (22,7%) show the highest annual rates in the number of mercantile companies created. In turn, La Rioja (-18.2%), Comunidad Foral de Navarra (-14.3%) and Castilla y León (-13.8%) registered the greatest decreases.


#### Annual variation in mercantile companies created by Autonomous Community March 2022. Percentage

In regards to dissolved merchantile companies, the highest rates were recorded in Cantabria (69.6%), Comunidad de Madrid (68.0%) and Región de Murcia (65.6%). On the other hand, the largest decreases were recorded in Castilla y León (-32,2%), Comunidad Foral de Navarra (-25,0%) and La Rioja (-18,8%).

### Revision and updating of data

Data for 2022 is provisional and will be reviewed when the data for the same period of the next year is published. In other words, when the data for February 2023 is published, the finalized data for the same month in 2022 will be released.

## Methodological note

The Mercantile Companies Statistics was created by Order of 30 December 1938. Its objective is to measure the demographics of companies, providing monthly information, at provincial and Autonomous Community level, on the companies created, dissolved and those in which there have been changes in capital.

The source of information is the Central Mercantile Registry, which collects all provincial information on the registration of companies and entrepreneurs, as well as mercantile acts determined by law.

Type of survey: monthly continuous survey.

**Population scope**: set of companies registered in the Central Mercantile Register.

Geographical scope: the entire national territory, by Autonomous Communities and provinces

Reference period of the results: the calendar month.

Reference period of the information: the calendar month

Collection method: administrative records.
