

Mercantile Companies Statistic

April 2007. *Provisional data*

The number of mercantile companies created in April increases 10.9% with respect to the same month of 2006

The interannual rate for the number of mercantile companies dissolved grows 36%

12,374 mercantile companies were created in April, 10.9% more than for the same month of 2006. The capital subscribed for their constitution exceeds 734 million euros, 9.5% more than in April of the previous year. In turn, **the average capital subscribed registers an interannual decrease of 1.2%**.

On the other hand, in April 3,416 mercantile societies increased their capital, 17.1% more than for the same month of 2006. The capital subscribed in the increases registered an interannual growth rate of 0.5% and exceeded 3,312 million euros. The average capital subscribed in these operations registered an interannual increase of 14.1%.


The number of dissolved companies in April was 887, which implies 36% more than in the same month of 2006. Of these, 82.3% did so voluntarily, 7% due to mergers and the remaining 10.7% for other reasons.

Private limited companies represent 98.9% of companies created in April 2007 and 90.4% of those increasing their capital.

Out of the 12,374 mercantile companies created in the month of April, 98.9% were private limited companies and 1% were public limited companies. Out of the 3,416 companies that increased their capital, 90.4% were private limited companies and 9.6% were public limited companies.

67.6% of the capital registered by the mercantile companies created was subscribed by private limited companies and 32.4% by public limited companies. Regarding the capital subscribed in capital increases, 53.3% corresponded to private limited companies and 46.6% to public limited companies.



The number of public limited companies created decreases 14.6% in April in their interannual rate and that of private limited companies increases 11.2%. Regarding companies increasing their capital, public limited companies increased 7.6% and private limited companies 18.2%.

The capital subscribed by public limited companies created increased 82.3% with respect to April 2006 and that subscribed by private limited companies decreased 8.1%. Regarding the capital subscribed by companies increasing their capital, there was an increase of 228.5% in the interannual rate for public limited companies and an decrease of 37.5% for private limited companies.

Principado de Asturias has the greatest average capital in companies created and País Vasco in those increasing their capital.

The autonomous community with the greatest average capital subscribed by mercantile companies created in April was Principado de Asturias (136,346 euros). In contrast, Cantabria was the community with the least average capital subscribed (13,426 euros).

País Vasco had the greatest average capital subscribed by companies increasing their capital (5,103,104 euros) and Cantabria had the lowest (137,200 euros).

Comunidad de Madrid concentrates 27.8% of the total capital subscribed by companies created.

Of the total capital subscribed in the creation of mercantile companies in the month of April, Comunidad de Madrid concentrated the highest percentage (27.8%). On the other end of the scale is Cantabria (0.2%).

Regarding the total capital subscribed by mercantile companies that increased capital, Comunidad de Madrid accumulates the highest percentage (32.8%) and Cantabria the lowest (0.1%).
