Mercantile Companies Statistics (MC)

April 2022. Provisional data

In April, 8,474 mercantile companies were created, 8.2% less than in the same month of 2021.

The number of companies dissolved was 1,661, with an annual decrease of 10.7%

In April, 8,474 mercantile companies were created, 8.2% less than in the same month of 2021. The subscribed capital for their constitution exceeded 282 million euros, with an annual decrease of 14.8%. The average subscribed capital (33,373 euros) decreased by 7.2%.

On the other hand, 2,212 mercantile companies increased their capital in April, 4.5% less than in the same month of 2021. The capital subscribed in the increases registered a decrease of 46.7% and reached 989,997 million euros. The average capital subscribed in these transactions (447,557 euros) decreased 44.2% in the annual rate.

The number of mercantile companies dissolved in April was 1,661, indicating 10.7% less than in the same month of 2021. Of these, 75.1% did so voluntarily, 14.4% due to mergers and the remaining 10.5% for other reasons.

Mercantile companies created, increasing their capital and dissolved April 2022



Evolution of the monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation of the number of mercantile companies created and dissolved between March and April in the last five years. In 2022, the monthly variation in the number of companies created was -23.5%, and -35.0% in the number of companies dissolved.

Performance of the monthly rate of mercantile companies created and dissolved


April variation is compared with March of the same year. Percentage




Results by main economic activity

Of the mercantile companies created in April, 18.9% corresponded to Trade and 16.8% to Real estate, financial and insurance companies. As for dissolved companies, the highest percentages are in *Trade* and *Construction*, both with 18.4%.

Mercantile companies created by main economic activity




Mercantile companies dissolved by main economic activity



The economic activity with the largest subscribed capital of mercantile companies created was *Real estate, financial and insurance*, with 150.31 million euros. In turn, *Information and communications* presented the lowest subscribed capital, with 2.89 million.


Capital subscribed of mercantile companies created by main economic activity April 2022. Thousands of euros



In regard to the average subscribed capital of the mercantile companies created, *Real Estate, financial and insurance* registered the highest, with 105,581 euros per company. In turn, *Information and communications* registered the lowest average, with 7,934 euros.

Results by Autonomous Community

The Autonomous Communities with the greatest number of mercantile companies created in April were Comunidad de Madrid (1,965), Cataluña (1,702), and Andalucía (1,472).

In turn, those in which the fewest mercantile companies have been created were La Rioja (27), Comunidad Foral de Navarra (61), and Cantabria (72).

In regard to dissolved mercantile companies, the Autonomous Communities that registered the highest number of dissolutions were Comunidad de Madrid (611), Andalucía (238) Cataluña and Comunitat Valenciana (128).


In turn, those with the lowest number of dissolutions were Comunidad Foral de Navarra (six), La Rioja (13) and Extremadura (21).


Illes Balears (19.4%), Canarias (11.5%) and Cataluña (7.9%) had the highest annual rates in the number of mercantile companies created. In turn, Castilla y León (-26.5%), Comunidad Foral de Navarra (-25.6%) and Principado de Asturias (-25.0%) registered the largest declines.

Regarding the mercantile companies dissolved, the highest rates were recorded in Comunidad Foral de Navarra (69.6%), Región de Murcia (66.7%) and La Rioja (62.5%). In turn, the greatest decreases were registered in Galicia (-28,6%), Aragón (-25,5%) and Castilla y León (-20,9%).

Revision and updating of data

Data for 2022 is provisional and will be reviewed when the data for the same period of the next year is published. In other words, when the data for February 2023 is published, the finalized data for the same month in 2022 will be released.

Methodological note

The Mercantile Companies Statistics was created by Order of 30 December 1938. Its objective is to measure the demographics of companies, providing monthly information, at provincial and Autonomous Community level, on the companies created, dissolved and those in which there have been changes in capital.

The source of information is the Central Mercantile Registry, which collects all provincial information on the registration of companies and entrepreneurs, as well as mercantile acts determined by law.

Type of survey: monthly continuous survey.

Population scope: set of companies registered in the Central Mercantile Register.

Geographical scope: the entire national territory, by Autonomous Communities and provinces

Reference period of the results: the calendar month.

Reference period of the information: the calendar month

Collection method: administrative records.
