Mercantile Companies Statistic

May 2007. *Provisional data*

The number of mercantile companies created in May decreases 4.5% with respect to the same month of 2006

The interannual rate for the number of mercantile companies dissolved grows 26.5%

13,967 mercantile companies were created in May, 4.5% less than for the same month of 2006. The capital subscribed for their constitution almost reaches 1,403 million euros, 46.5% more than in May of the previous year. In turn, **the average capital subscribed registers an interannual increase of 53.4%.**

On the other hand, in May 4,082 mercantile societies increased their capital, 6.4% more than for the same month of 2006. The capital subscribed in the increases registered an interannual growth rate of 11.4% and almost reaches 3,280 million euros. The average capital subscribed in these operations registered an interannual increase of 4.7%.

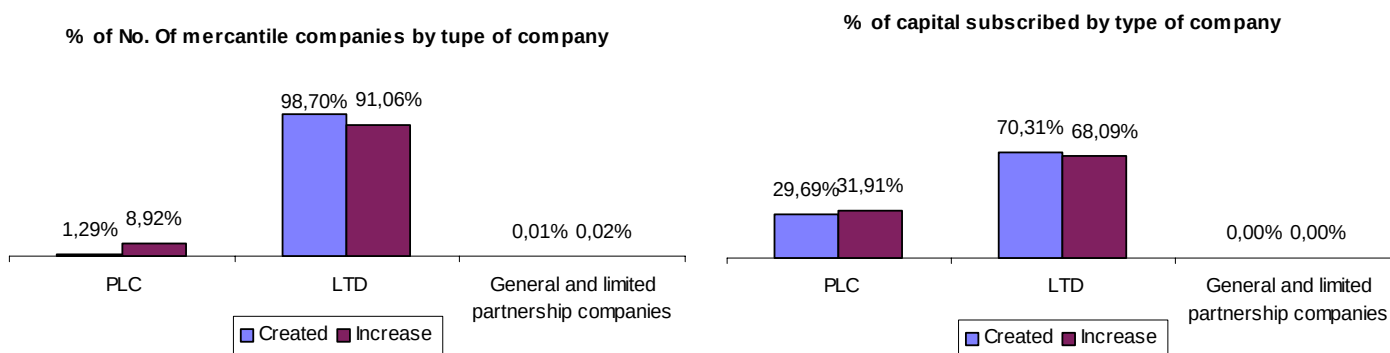
The number of dissolved companies in May was 1,030, which implies 26.5% more than in the same month of 2006. Of these, 82.8% did so voluntarily, 8.7% due to mergers and the remaining 8.4% for other reasons.

Private limited companies represent 98.7% of companies created and 91.1% of those increasing their capital.

Out of the 13,967 mercantile companies created in the month of May, 98.7% were private limited companies and 1.3% were public limited companies. Out of the 4,082 companies that increased their capital, 91.1% were private limited companies and 8.9% were public limited companies.

70.3% of the capital registered by the mercantile companies created was subscribed by private limited companies and 29.7% by public limited companies. Regarding the capital subscribed in capital increases, 68.1% corresponded to private limited companies and 31.9% to public limited companies.



The number of public limited companies created decreases 14.3% and of the private limited companies decreases 4.4%, in their interannual rate. Regarding companies increasing their capital, public limited companies decreased 9% and private limited companies increased 8.2%.

The capital subscribed by public limited companies created decreased 1.9% with respect to May 2006 and that subscribed by private limited companies increased 85%. Regarding the capital subscribed by companies increasing their capital, there was a decrease of 0.4% in the interannual rate for public limited companies and an increase of 17.9% for private limited companies.

Galicia has the greatest average capital in companies created and Comunidad Foral de Navarra in those increasing their capital.

The autonomous community with the greatest average capital subscribed companies created in May was Galicia (511,310 euros). Illes Balears was the community with the least average capital subscribed (21,043 euros).

Comunidad Foral de Navarra had the greatest average capital subscribed by companies increasing capital (7,170,571 euros) and Castilla-La Mancha had the lowest (211,317 euros).

Comunidad de Madrid concentrates 38.7% of the total capital subscribed by companies created.

Of the total capital subscribed in the creation of mercantile companies in the month of May, Comunidad de Madrid concentrated the highest percentage (38.7%). On the other end of the scale is La Rioja (0.1%).

Regarding the total capital subscribed by mercantile companies that increased capital, Cataluña accumulates the highest percentage (29.3%) and La Rioja the lowest (0.2%).
