Mercantile Companies Statistics (MC) May 2022. Provisional data

In May, 9,132 mercantile companies were created, 4.6% less than in the same month of 2021.

The number of companies dissolved was 1,728, with an annual increase of 0.3%

In May, 9,132 mercantile companies were created, 4.6% less than in the same month of 2021. The subscribed capital for their constitution exceeded 376 million euros, with an annual increase of 12.9%. The average subscribed capital (41,183 euros) increased by 18.3%.

On the other hand, 2,454 mercantile companies increased their capital in May, 2.6% less than in the same month of 2021. The capital subscribed in the increases registered a increase of 38.6% and reached 1,571 million euros. The average capital subscribed in these transactions (639,987 euros) increased 42.3% in the annual rate.

The number of mercantile companies dissolved in May was 1,728, indicating 0.3% more than in the same month of 2021. Of these, 76.3% did so voluntarily, 8.4% due to mergers and the remaining 15.3% for other reasons.


Evolution of the monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation of the number of mercantile companies created and dissolved between April and May in the last five years. In 2022, the monthly variation in the number of companies created was 7.8%, and 4.0% in the number of companies dissolved.

Performance of the monthly rate of mercantile companies created and dissolved May variation is compared with April of the same year. Percentage




Results by main economic activity

Of the mercantile companies created in May, 20.9% corresponded to *Trade* and 15.7% to *Real* estate, financial and insurance companies. Regarding dissolved companies, 19.4% corresponded to *Trade* and 18.3% to *Construction*.


Mercantile companies created by main economic activity

May 2022. Percentage




Mercantile companies dissolved by main economic activity May 2022. Percentage

The economic activity with the largest subscribed capital of mercantile companies created was *Real estate, financial and insurance*, with 151.55 million euros. In turn, *Information and communications* presented the lowest subscribed capital, with 2.70 million.


Capital subscribed of mercantile companies created by main economic activity May 2022. Thousands of euros



In regard to the average subscribed capital of the mercantile companies created, *Real Estate, financial and insurance* registered the highest, with 105,704 euros per company. In turn, *Information and communications* registered the lowest average, with 7,221 euros.

In May, the Autonomous Communities with the greatest number of mercantile companies created were Cataluña (1,977), Comunidad de Madrid (1,944) and Andalucia (1,544).

In turn, those with the lowest number of mercantile companies created were La Rioja (35), Cantabria (72) and Comunidad Foral de Navarra (84).

In regard to dissolved mercantile companies, the Autonomous Communities that registered the highest number of dissolutions were Comunidad de Madrid (538), Andalucía (288) and Comunitat Valenciana (167).


In turn, those with the lowest number of dissolutions were Comunidad Foral de Navarra (zero), La Rioja (17) and Extremadura (21).


Illes Balears (30.4%), Cataluña (4.6%) and Comunitat Valenciana (1.9%) had the highest annual rates in the number of mercantile companies created. In turn, Región de Murcia (-27.7%), Extremadura (-25.8%) and País Vasco (-23.7%) registered the largest decreases.

Regarding the mercantile companies dissolved, the highest rates were recorded in Principado de Asturias (69.6%), La Rioja (30.8%) and Canarias (18.5%). In turn, Comunidad Foral de Navarra (-100.0%), Illes Balears (-44.2%) and Aragón (-30.0%) registered the greatest decreases.

Revision and updating of data

Data for 2022 is provisional and will be reviewed when the data for the same period of the next year is published. In other words, when the data for February 2023 is published, the finalized data for the same month in 2022 will be released.

Methodological note

The Mercantile Companies Statistics was created by Order of 30 December 1938. Its objective is to measure the demographics of companies, providing monthly information, at provincial and Autonomous Community level, on the companies created, dissolved and those in which there have been changes in capital.

The source of information is the Central Mercantile Registry, which collects all provincial information on the registration of companies and entrepreneurs, as well as mercantile acts determined by law.

Type of survey: monthly continuous survey.

Population scope: set of companies registered in the Central Mercantile Register.

Geographical scope: the entire national territory, by Autonomous Communities and provinces

Reference period of the results: the calendar month.

Reference period of the information: the calendar month

Collection method: administrative records.
