### In July, 7,820 mercantile companies were created, 1.6% more than in the same month of 2018

# Principado de Asturias (68.8%), La Rioja (35.5%) and Comunidad de Madrid (10.2%) registered the highest annual increases in the number of mercantile companies created

In July, 7,820 mercantile companies were created, 1.6% more than in the same month of 2018. The share capital for their constitution exceeded 804 million Euros, with an annual increase of 34.3%. The average subscribed capital (102,864 euros) increased by 32.1%.

On the other hand, 2,541 mercantile companies increased their capital in July, 7.2% less than in the same month of 2018. The capital subscribed in the increases recorded a 21.2% decrease and exceeded 1,842 million euros. The average capital subscribed in these transactions (724,967 euros) decreased by 15.1% in the annual rate.

The number of mercantile companies dissolved in July was 1,622, 9.2% more than in the same month of 2018. Of these, 69.0% did so voluntarily, 18.0% due to mergers and the remaining 13.0% for other reasons.



#### **Evolution of the monthly rate**

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation of the number of mercantile companies created and dissolved between June and July in the last five years. In 2019, the monthly variation in the number of companies created was 5.2% and the number of companies dissolved was 29.2%.


### Performance of the monthly rate of mercantile companies created and dissolved July variation is compared with June of the same year. Percentage




### Results by main economic activity

19.1% of the mercantile companies created in July correspond to *Trade* and 17.6% to *Real* estate, financial and insurance companies. Regarding dissolved companies, 22.7% corresponded to *Industry and energy* and 17.8% to *Trade*.

#### Mercantile companies created by main economic activity




#### Mercantile companies dissolved by main economic activity



The economic activity with the greatest subscribed capital of mercantile companies created was *Real estate, financial and insurance activities*, with 610.88 million euros. In turn, *Administrative and support service activities* registered the lowest capital, with 3.10 million.

#### **Results by Autonomous Community**

The Autonomous Communities with the greatest number of mercantile companies created in July were Comunidad de Madrid (1,972), Cataluña (1,510), and Andalucía (1,272). Conversely, the Autonomous Communities where less mercantile companies were created were La Rioja (42), Cantabria and Comunidad Foral de Navarra (both with 45).


Regarding dissolved mercantile companies, the Communities that registered the highest number were Comunidad de Madrid (519), Comunitat Valenciana (258) and Andalucía (208). In turn, those with the lowest number of dissolved companies were Comunidad Foral de Navarra (4), La Rioja (7) and Región de Murcia (17).


Principado de Asturias (68.8%), La Rioja (35.5%) and Comunidad de Madrid (10.2%) registered the highest annual increases in the number of mercantile companies created. In turn, Aragón (-19.7%), Illes Balears (-13.6%) and Cantabria (-10.0%) registered the greatest decreases.

Regarding mercantile companies dissolved, the highest rates were recorded in Cantabria (200.0%), Comunitat Valenciana (88.3%) and Comunidad Foral de Navarra (33.3%). Conversely, Castilla-La Mancha (-26.5%), Comunidad de Madrid (-11.9%) and Cataluña (-2.8%) showed the greatest decreases.

#### Revision and updating of data

Data for 2019 are provisional and will be reviewed when the data for the same period of the next year are published. In other words, when the data for July 2020 are published, the final data for the same month of 2019 will be disseminated.

### Methodological note

The Mercantile Companies Statistics (MCS) was created by Order of 30 September 1938. Its objective is to measure the demographics of companies, providing monthly information, at provincial and Autonomous Community level, on the companies created, dissolved and those in which there have been changes in capital.

The source of information is the Central Mercantile Registry, which collects all provincial information on the registration of companies and entrepreneurs, as well as mercantile acts determined by law.

Type of survey: monthly continuous survey.

Population scope: set of companies registered in the Central Mercantile Register.

**Geographical scope**: the entire national territory, by Autonomous Communities and provinces.

Reference period of the results: the calendar month.

**Reference period of the information**: the calendar month.

**Collection method**: administrative records.
