Mercantile Companies Statistics (MC)

November 2019. Provisional data

In November, 7,331 mercantile companies were created, 8.0% less than in the same month of 2018

The share capital for their constitution exceeded 320 million Euros, with an annual increase of 4.9%

In November, 7,331 mercantile companies were created, 8.0% less than in the same month of 2018. The share capital for their constitution exceeded 320 million Euros, with an annual increase of 4.9%. The average subscribed capital (43,739 euros) increased by 14.0%.

On the other hand, 2,345 mercantile companies increased their capital in November, 8.0% less than in the same month of 2018. The capital subscribed in the increases recorded a 24.2% decrease and exceeded 2,306 million euros. The average capital subscribed in these transactions (983,481 euros) decreased by 17.7% in the annual rate.

The number of mercantile companies dissolved in November was 1,982, which is 0.5% less than in the same month of 2018. Of these, 81.2% did so voluntarily, 7.8% due to mergers and the remaining 11.0% for other reasons.



Evolution of the monthly rate

In order to contribute to the analysis and interpretation of the data, the following chart shows the variation of the number of mercantile companies created and dissolved between October and November in the last five years. In 2019, the monthly variation in the number of companies created was -8.7% and in the number of companies dissolved 13.7%.


Performance of the monthly rate of mercantile companies created and dissolved November variation is compared with October of the same year. Percentage




Results by main economic activity

Of the mercantile companies created in November, 19.1% corresponded to *Trade* and 16.4% to *Real estate, financial and insurance companies*. Regarding the dissolved companies, 21.6% corresponded to *Trade* and 17.4% to *Construction*.

Mercantile companies created by main economic activity




Mercantile companies dissolved by main economic activity



The economic activity with the greatest capital subscribed of mercantile companies created was Real estate, financial and insurance activities, with 207.46 million euros. In turn, *Administrative and support service activities* registered the lowest capital, with 2.94 million.

Results by Autonomous Community

The Autonomous Communities with the greatest number of mercantile companies created in November were Comunidad de Madrid (1,865), Cataluña (1,380), and Andalucía (1,217). In turn, those with the lowest number of mercantile companies created were La Rioja (26), Cantabria (37) and Comunidad Foral de Navarra (51).


Regarding dissolved mercantile companies, the ones that registered the highest number were Comunidad de Madrid (645), Andalucía (265) and Cataluña (154). In turn, those with the lowest number of dissolutions were Comunidad Foral de Navarra (10), Región de Murcia (16) and La Rioja (17).


La Rioja (30.0%), Principado de Asturias (11.4%) and Aragón (4.1%) have the highest annual rates in the number of mercantile companies created. In turn, Cantabria (-49.3%), Comunidad Foral de Navarra (-37.0%) and Región de Murcia (-23.4%) registered the greatest decreases.

As regards the dissolution of mercantile companies, the highest rates were recorded in La Mancha (112.5%), Comunitat Valenciana (42.9%) and Illes Balears (27.5%). On the other hand, Región de Murcia (-59.0%), Principado de Asturias (-41.8%) and Extremadura (-20.0%) registered the largest decreases.

Revision and updating of data

Data for 2019 are provisional and will be reviewed when the data for the same period of the next year are published. In other words, when the data for November 2020 is published, the final data for the same month of 2019 will be disseminated.

Methodological note

The Mercantile Companies Statistics (MCS) was created by Order of 30 September 1938. Its objective is to measure the demographics of companies, providing monthly information, at provincial and Autonomous Community level, on the companies created, dissolved and those in which there have been changes in capital.

The source of information is the Central Mercantile Registry, which collects all provincial information on the registration of companies and entrepreneurs, as well as mercantile acts determined by law.

Type of survey: monthly continuous survey.

Population scope: set of companies registered in the Central Mercantile Register.

Geographical scope: the entire national territory, by Autonomous Communities and provinces.

Reference period of the results: the calendar month.

Reference period of the information: the calendar month.

Collection method: administrative records.
